Forestry Men To Open Meet

SALEM, April 2 (AP)—More than 100 state forestry officials will open a three-day conference here tomorrow to discuss plans for fire protection for the coming fire season.

The men will include district wardens and their assistants, inspectors, and other key men of the state forestry department and forest protective associations. They also will discuss the state forest conservation law, state land acquisition, public relations and summer forest closures.

State Forester N. S. Rogers said plans will be made for an intensive course of instruction covering job training. This schooling will include organization of emergency camps and training of fire crews, fire line construction, snag falling, use of equipment, and other aspects of fire suppression.

Death Claims Noted Author

NEW YORK, April 2 (AP)—Edward Brewster Sheldon, 60, author of many Broadway play successes, who carried on as an adviser to "big names" in the theatrical world despite 20 years of blindness and partial paralysis, died of coronary thrombosis at his home here yesterday.

"Dishonored Lady," his last play, was produced here in 1930 with Katharine Cornell as the star, but since that time Sheldon had been consulted constantly by such notables of the theatrical world as Miss Cornell and Helen Hayes.

One of Sheldon's first plays, "The Nigger," seen here in 1909, was among the earliest theatrical treatments of the status of Negroes in the south.

"Romance," which opened in 1913 with Doris Keane as its star, was perhaps his greatest success. Others were "Lulu Belle," which starred Lenore Ulric, "Jenny," featuring Jane Cowell, "My Princess," "Be-witched," written with Sidney Howard, and "The Garden of Paradise."

Sheldon established himself as a playwright at 22 when the late Mrs. Minnie Maddern Fiske produced and starred in his "Salvation Nell."

Wallace Beery True To Adage

HOLLYWOOD, April 2 (AP)—Wallace Beery, his voice showing none of the tears that were in his eyes, proved again last night the theatrical adage that the show must go on.

Only hours after his elder brother, Noah, died in his arms of a heart attack, Wallace and his adopted daughter, Carol Ann, made a scheduled radio broadcast of "Barnacle Bill," with another actor in the role Noah was to have played.

The brothers, always close, had parallel careers for many years, both on the stage and in films. Their last joint film appearance was last year in "This Man's Navy."

Noah, 63, was stricken here while on a two-week vacation from "Up in Central Park," the hit New York musical in which he has played Boss Tweed. Sunday night he attended Wally's 60th birthday party.

Funeral arrangements are pending.

Canadian GI Denies Charge

CALGARY, Alta., April 2 (AP)—Cpl. R. J. (Tiny) Morgan of the Canadian army, who was arrested at Currie barracks here yesterday, has denied charges by police that he is Ralph J. Selz, who escaped from the California Institute for Men, May 3, 1945.

Morgan was arrested earlier in the day by Royal Canadian Mounted police in connection with the search for Selz, who had served nine years of a life sentence for first degree murder at Redwood City, Calif.

The arrest warrant was issued by Chief Judge J. W. McDonald.

Negroes Vote Right Upheld

WASHINGTON, April 2 (AP)—The supreme court Monday declined to review lower federal court rulings that negroes are entitled to vote in democratic primary elections in Georgia.

The rulings were given on litigation begun by Primus E. King, a negro of Muscogee county, Ga., who was denied the right to vote in a recent primary. A U. S. district court in Georgia said the denial violated King's rights under the federal constitution. The federal court of appeals in New Orleans upheld the district court.

Members of the Muscogee county democratic executive committee, who were in charge of the primary, said King was denied a vote because of a party rule restricting the election to white electors. In petitioning for a review, they said:

"The petitioners are honestly and sincerely of the opinion that under Georgia law, and under the Georgia system wherein a party voluntarily comes into being and is not created by law, they have a right to confine the right of suffrage in primaries to white citizens."

The supreme court gave no reason for its refusal to review.
