

Hitchcock Asks Action On Airport

A halting, indecisive policy with respect to use of the Klamath municipal airport is not in keeping with Klamath's progressive spirit, Phil Hitchcock, director in charge of aviation for the Klamath County chamber of commerce, said in an interview on Monday.

Hitchcock expressed the opinion that local aviation, at its present stage of development, would produce enough revenue to finance management of the airport, which is currently held in an idle state by the navy pending some permanent agreement with the city.

He outlined the proposal of private fliers to assume management responsibilities, but said that a modification of that plan, whereby the management would be under city control, might well be worked out.
