Today's Roundup

By MALCOLM EPLEY TWICE in the last few days, congress has rejected labor legislation that has been described as excessively drastic, hasty, un-American, unconstitutional, prejudiced, hysterical, born of fear and anger, bigoted, extreme, anti-labor, class legislation, and so on through the gamut of denunciatory terminology.

It has been denounced by violent people, and sober-minded people, hot-heads and cool-heads, radicals, middle-of-the-roaders, conservatives. If only a small measure of this condemnation is true, one would suppose that the odds against its passage in the congress of the United States would be terrific. It is amazing that it should even be introduced.

What Happened NOW, consider what has happened. Much that is said in criticism of these legislative proposals is absolutely true, but—They came within a narrow squeak of adoption.

One measure was proposed by the president of the United States, it passed one house overwhelmingly, and had to be "emasculated" in the other house.

The other proposal passed both houses, was vetoed by the president and was saved from passage over his veto by just a handful of votes.

All of this occurred among people who are sensitive to the opinion of the American public, a vast majority of them holding office which was given to them by votes of their constituents less than two years ago.

Dangerous Ill—Dangerous Cure LET us agree that it is fortunate these measures were stopped short of adoption. But the very fact they reached that point must make us realize they represent a dangerous remedy offered for a dangerous condition.

People who are disturbed by the suggestion of strong medicine should be more greatly disturbed by the illness it is intended to cure. It is safe to say that some of those who cried loudest against the drastic legislation contributed heavily to the conditions that brought that legislation before congress—and to the point of adoption.

Basic THERE is a need for all of us to go deeper than the expression of our opinion of legislative proposals in congress. As citizens who don't want such drastic measures, invading long-established rights of our people, we must work together to change the conditions that brought about their proposal.

The World Today By DeWITT MACKENZIE AP Foreign Affairs Analyst Word that the powerful Grand Mufti of Jerusalem—who is anti everything that is British or Jewish—has evaded surveillance in France and again is at large somewhere among the Moslems of the Middle East, isn't calculated to ease the crisis which has arisen in Palestine over the fiery problem of Jewish immigration.

The highly educated Grand Mufti is a dangerous man to those against whom he conspires. For many years he has been leader of the Arab campaign for an independent Palestine and against the establishment of a Jewish national home as proposed by the British. And it is an ironic circumstance that it was Sir Herbert Samuel, first British high commissioner of Palestine under the League of Nations mandate, who appointed him mufti.

The 53-year-old Haj Amin El Hussein—to give him his name—not only is spiritual head of Palestine's some 1,000,000 Moslem Arabs but is political leader as well. Moreover his influence extends into Trans-Jordan, Iraq, Arabia, Egypt, Iran and Syria, for he is gifted with leadership, has a strong personality and is as crafty as a fox.

War on Jews Most of his life, Hussein has made war on the Jews of Palestine, indeed in 1920, when his brother was Grand Mufti, he fled to Trans-Jordan after being sentenced to ten years imprisonment for his part in anti-Jewish riots. Next year the brother died and Haj Amin was granted amnesty, after which High Commissioner Samuel appointed him Grand Mufti, it being the custom for this high office to remain in the same family.

Whereabouts Unknown Now the Grand Mufti is loose again and is reported to have gone by air to Syria, but his whereabouts is a mystery. The general supposition is that he is taking a hand in the Arab fight against Jewish immigration to Palestine. The point of his going to Syria would be that (1) it is an old stamping ground of his and that (2) the Arab league council is now meeting at Bludan, Syria, to discuss the report of the Anglo-American committee of inquiry which recently recommended that 100,000 European Jews be admitted to Palestine in one year.

WE NEED PRODUCTION KLAMATH FALLS, Ore. (To the Editor)—The address of Postmaster General Hannegan to the Missouri chapter of the National Association of Postmasters in St. Louis was a revelation of no small consequence. This address by Postmaster General Hannegan is the first time that I've ever seen in print an admission, by any Big Shot, that the current INFLATION was started, not by labor, but by Big Business.

When the war began, in spite of the so-called freezes, prices soared but wages remained almost stationary in comparison. Some of the commodities we workers needed for our living expenses doubled before we ever got a raise. When the war ended we were worse off, as far as wages and prices were concerned, than before the war.

Now the war is over and the workers are endeavoring to reach the same level they had before the war. There is no war now to demand the patriotism that was fully extended by the working people during the war.

Capital's profits were extended during the war to an unprecedented high. Capital NOW is not satisfied to return to a reasonable profit but wishes to retain the wartime margin. Therefore, the working people are patriotic by trying to equalize their profit from their product, to their living costs.

Big Business has been staging a quiet sit-down strike because of OPA and their margins. All right! Let's get rid of OPA and let prices rocket to wherever they go. Profits for the big business will boom production. Those of us that don't have the dough can WAIT. When we get the production, competition will bring the prices down to US. Production is what we need for reconversion.
