**Chamber Urges Barracks Plan**

Chamber of commerce directors voted today to urge the state to proceed with plans for a vocational school at the marine barracks on the basis of the presently offered terms of the war assets administration.

These terms would give the barracks to the state for \$1 if the state uses the plant for 25 years, with provisions for purchase at discounts if the state wants to use it for some other purpose in the set period. Chamber directors agreed it was time to press vigorously for action in view of the fact the legislature is in session.

Chamber action was taken today in the wake of a refusal by the WAA to alter its offer to the state. Directors indicated opinion that the offer is a fair one.

look at the crowds that come out to be fed and wonder where all the people come from.

THESE Knotts, from the great-grandfather down, have indulged a hobby. Their hobby is and has been the re-creation, in so far as it has been possible within their means to do so, of the romantic past of gold-bearing California.

They have assembled and set up a ghost town of the early mining days, complete down to the saloons and the jail and even to the bawdy-house that was an inevitable part of the rough life of that day—with a wax-figure bond peeping from an upper window and a red lantern hanging from the porch. All these re-creations are historically authentic.

At the other end of the moral scale, they have a simple and impressive little chapel, beside a lovely little lake, in which by the ledgerman of modern lighting is re-enacted realistically before your eyes. On the way West, the original Knott and his family were caught on a waterless desert, drove all night and during the night stood off an Indian attack. They have made a diorama of this—and it is a real work of art. Your hair stands on end when, again by the magic of modern lighting, the redskins leap to the attack.

ALL this is free. If you wish, you can wander and look all afternoon and never dig for the folding money once. Here and there are museum-piece old music boxes, and if you are so moved you can drop in a nickel and listen to their tinkling melodies. But that is between you and your God. There is no urge to do so.

They make their money out of their eating houses and their stores where the products of the farm are sold. The rest is background—and you sense that its creation has been as much labor of love as shrewd money-wangling.

It is certainly worth seeing.

**Barkley Gets Assault Charge**

John "Jackie" Barkley, 20-year-old Klamath Indian, was charged with assault with a dangerous weapon in connection with the alleged beating of Richard Powell, Chiloquin restaurant operator, and this morning waived preliminary hearing before U. S. Commissioner Bert C. Thomas. Barkley was lodged in the Klamath county jail in lieu of \$2500 bail and will be moved to Portland this week-end, according to Special Indian Officer John Arkeell.

Young Barkley, who is not over 5 feet 2 inches tall, is credited with beating Powell with a short-handled sledge hammer late Tuesday night at the Harold Wright ranch near Modoc Point after Powell, Barkley and two Indian women had been in Klamath Falls drinking, Arkeell said. No charges were filed against the women. Powell, operator of the Cross Cut cafe, was able to be moved to his home today from Hillside hospital.
