

Father Finds Missing Son

EVERETT, March 26 (AP)—Lost since shortly after noon Monday, 4-year-old Dennis Yatty was found at 6:30 a. m. Tuesday snuggled against his cocker spaniel in the shelter of a fallen tree in a swamp south of here. He was found three-quarters of a mile from his home in the Silver Lake region.

The lightly clad youngster, apparently unharmed, although wet and cold, was brought to an Everett hospital for observation.

Dennis was found by his father, John R. Yatty, and the family's collie dog. Yatty had searched without rest throughout the night. "I heard Susan (the cocker) growling at the collie. I knew that Dennis was there," said Yatty.

He said Dennis was lying on his side, his back pressed against the log and that the little spaniel lay protectively against him in front. When Yatty approached, Dennis opened his eyes sleepily and stared up at his father. Yatty lifted the boy tenderly and kissed his tear-stained cheek.

Then the father shouted his glad tidings to the 100 others who had been hunting the youngster ever since he wandered away while his mother was doing the week's wash.

Wagner Jury Hears Testimony

began "roughing" him up while he tried to protect himself. After the alleged beating, Farris said he tried to leave the police station but at that point he was stopped and booked by the desk sergeant. Farris said the officers then threw him in jail.

Under examination of the defense attorney, Herbert P. Welch of Lakeview, Farris admitted that following the beating he had said to Chief of Police Orville Hamilton and Wagner: "I blew my top and got what was coming to me."

He admitted that he said later to Wagner: "I'm sorry I called you a liar." Asked why he had made these statements, Farris told Welch he "was afraid of what the police might do" to him if he held the beating against them.

Albert A. Farris, father of Bob Farris, was called to the stand but before testifying asked Judge Combs: "Is this a case against Bob Farris or Wagner?"

The elder Farris said he had seen Wagner the next day and that Wagner had apologized for the beating. He said that he was not allowed to see his son at that time.

Final witness of the state was Dr. Peter H. Rosendal of Corvallis, former Klamath county health officer, who said he was city health officer at the time of the alleged beating and had been called to treat Farris' wounds. He said that in his opinion the blow was "a moderate one."

The defense asked for a recess until 2 p. m. today due to the absence of witnesses.

Members of the jury hearing the case are Tom Picard, Ray Ledbetter, B. L. Hardenbrook, G. K. Van Riper, Ben H. Gibson, S. J. Herringshaw, Cecil B. Matt, Frank Victorine, Ralph Hill, A. D. Addison, George P. Davis and Floyd Underhill. In his interrogation of the veniremen Humble stressed the question of whether the prospective juror thought that a police officer had any special privileges, more than those given a private citizen.

Humble used his three pre-emptory challenges in dismissing three veniremen, and Welch used two of his six. The number 12 seat in the jury box seemed to hold a jinx. Six jurors were excused before it was finally filled with the next to the last remaining man from the special venire of 15 persons, which was called to supplement the regular panel.

Old Age Pay Gets Support

SACRAMENTO, March 26 (AP)—Advocates of liberalized old age assistance benefits had the support of one assembly committee today but the major benefits proposed still had to run the gauntlet of the ways and means committee before reaching the floor of the lower house.

Applauded by several hundred members of the state's Townsend clubs, the assembly social welfare committee gave do pass recommendations to:

AB 124, by Ralph E. Dills, to strike out the relative responsibility clause under which adult children are required to contribute to the support of parents eligible for old age assistance.

AB 138, by Dills, to increase the state's contribution so that recipients will receive \$80 a month instead of the present \$55 on a permanent basis.

AB 751 by Kathryn Niehouse and 41 co-authors, changing title of old age security law to "senior citizens grants law," to establish a recipient's "need" as \$75 a month so that a total of \$75 month income, counting outside income, could be realized.

AB 1520 by Kilpatrick, raising from \$600 to \$1000 the amount of personal property and old age assistance recipient could own and still be eligible for old age pensions.

AB 477 by Evans, increasing monthly old age payments to \$75, for two years only.
