

Divorced Husband Shoots Wife, Critically Wounds Her Father In Quarrel

SNOHOMISH, Wash., June 21 (AP)—A wild outburst of shots in a trailer camp killed Mrs. Anna Rose Simpson, 23, and wounded her father critically late yesterday and State Patrolman Everett Olsen reported he arrested the woman's divorced husband a few minutes later, wresting a .38 caliber revolver from his hands.

The patrolman said Homer A. Simpson, 31, a Vancouver, Wash., machinist, told him: "I'm the guy that did it."

Simpson was booked at the Snohomish city jail and later taken to the Everett jail by Sheriff Tom Warnock. He was held on an open charge.

At the Snohomish General hospital, Robert H. Cole, 53, a Bonneville administration worker, was conscious and in a "fair" condition this forenoon, Mrs. C. M. Torgerson, superintendent, said.

The father was shot attempting to defend his daughter, Sheriff Warnock said. The couple were divorced a month ago after a year's separation and Simpson had come to Snohomish to see their two children, Audrey, 4, and Bobby, 8 months. A quarrel ensued between him and his former wife.

As she returned to the camp late yesterday, her former husband was following her, the sheriff said. Cole
