Park Board Asks Land

A request that city-owned land for the Conger recreation park be turned over to the park board will be made to the city council Monday after the matter was discussed at a recreation committee meeting Tuesday in the city hall. The recreation committee decided that the property should be placed under the supervision of the park board, to be used for recreational purposes, as the equipment necessary for developing the field is owned by the park board.

A brief summary of recreational activity from June 16 to August 2 was presented to the committee by Samuel Smith, superintendent of

recreation. The report shows that approximately 9962 children have been given swimming instruction and 2900 people enjoyed open swimming during the evening at the high school pool. Private clubs have also taken advantage of the Thursday evening swimming program with 423 people swimming during that period. Total receipts amount to \$2626.20.

While totals of activity participation is not complete in other fields, the arts and crafts classes are teaching approximately 290 children a week, each class being three hours in duration. In wood-working groups 295 children are attending two-hour classes each week. At the five play centers there is an average of 443 hours of instruction each week in 21 different activities. By taking count of children participating in free play activities at 10 a. m. and 3 p. m. it is estimated that about 1285

children use the playgrounds during a week.
