NOTICE TO PROPERTY OWNERS: WHEREAS THE CITY OF Klamath Falls, Oregon, has been found liable for the cost of improving the portion of the city of Klamath Falls, Oregon, lying to the northeast of South Sixth Street, and known as sewer unit No. 17, that they have twenty days from the date of publication of this notice to file an application to pay the assessments in ten equal installments.

WHEREAS, the Common Council of the City of Klamath Falls, Oregon, and by Ordinance No. 412, adopted the lot of December, 1947, declared the proportionate assessment on each lot, part of lot, block, or parcel of acreage property found to be benefited for a proportionate share of the cost of improving that portion of Precinct No. 21, lying to the northeast of South Sixth Street, all as more fully and in detail shown on the plans and specifications of the matter of said improvement.
