

Governor Wins Collier's Suit

TALLAHASSEE, Fla., March 11 (AP)—A 12-man federal court jury yesterday awarded Gov. Millard Caldwell \$237,500 damages in his libel suit against Collier's magazine.

The jury, which included three negroes, deliberated two hours.

Caldwell, who had asked for \$500,000 damages, commented, "I think the verdict is justified by the law and by the facts."

Caldwell has said any proceeds from the litigation will go to Florida A and M college for negroes, a state-supported institution here.

Collier's attorneys announced a motion for a new trial will be made.

The governor claimed he was libeled in a Collier's editorial on his statement in connection with the killing of Jesse James Payne, a negro, was taken from the Madison county jail and shot while he was awaiting trial on charges of attempting to rape the five-year-old niece of Madison County Sheriff Loumie T. Davis.

He denied he made the statement attributed to him by the magazine.
