## Timber Cost Hits \$10,776

Puckett and Scherer of Keno, who were successful bidders for 599,099 board feet of timber in Jackson county at the March sale held recently by the bureau of land management for O. and C. lands, obtained the timber for a consideration of \$10,776.50, according to E. K. Peterson, district forester at Medford.

The operators paid \$22.50 per thousand for the ponderosa and sugar pine; \$14 per thousand for the Douglas fir. The appraised value was: Douglas fir, \$14; ponderosa pine, \$15.29; sugar pine, \$15.70. The Fir Milling and Planning company of Ashland, an unsuccessful bidder, offered \$8500, Peterson said.

Although the timber in question is in Jackson county, it is located in the Klamath master unit and marketing area, as established by Secretary of the Interior Julius Krug in November, 1947. For the entire sale covering all of the O. and C. area in Western Oregon there were 37 parcels of timber advertised and 22 parcels sold, representing 63,295,000 board feet for \$67,614—19 per cent above the appraised value.

## Test Lights To Be Tried

The city street committee voted to install a test system of lights on 11th street from Washington to Pine. The Soroptimist club recently asked that the city add lights along that area and along Esplanade.

Club members said that many school children travel both streets, and at present they are not sufficiently illuminated.

Street committees agreed to wait on the Esplanade lighting until something is done about the north entrance highway in Klamath Falls which will come down Esplanade.

Cost of the 11th street project will be shared by the power company since it will be a test plan just to see what type of lights can best be used.
