

# Washington Delegation For Dewey

BELLINGHAM, Wash., May 17 (AP)—Washington's delegation to the national republican presidential nominating convention had a Dewey tinge today, but whether the coloring was faint or deep-very was uncertain.

Spokesmen for rival candidates each had a different interpretation of the 19-man delegation.

State Sen. Harry Wall, state chairman of the New York governor's campaign, claimed "16 or 17" members of the delegation.

Joe Pearson of Seattle, leader of the Harold E. Stassen forces, and Judge Charles Paul, Seattle, head man for Sen. Robert A. Taft, each claimed four delegates for his candidate.

Non-partisan observers tabbed 16 delegates as Dewey supporters, three as neutral. At least two of those listed in the Dewey camp, however, declared later they were not committed to any candidate.

Election of the 19-member delegation to the Philadelphia convention climaxed the party's day-long state convention here Saturday.

Delegates-at-large elected were: first district—former Gov. Arthur B. Langlie; second—State Rep. Grant Sisson, Skagit county; third—Mrs. Ruth Lamb, Hoquiam; fourth—D. V. Northland, Yakima; fifth—Mrs. Marion Schulte, Spokane; sixth—Dr. O. G. Bultion, Tacoma. At large without district—W. W. Scruby, Seattle.

# Farm Hand Hurt Saturday

Forrest Everhart, about 50, was brought to Klamath Valley hospital Saturday for emergency treatment for injuries sustained in a farming accident. Everhart, an employe of Hooper brothers of Midland, was run over by a piece of farm machinery at Tulelake.

Everhart was saved from serious injury by being pushed into soft ground beneath the heavy farm implement. Chest X-rays were taken Saturday afternoon, and hospital attendants said that the man was not in critical condition.

# Seed Laws To Be Tightened Up

PORTLAND, May 17 (AP)—Oregon is going to tighten its requirements on seed certification.

Frank McKennon, chief of the state department of agriculture inspection division, asserted Saturday the state got into trouble last year because of lax inspection.

Several shipments of certified vetch seeds turned out to be infested with weevils, he said, adding that fumigating and labeling requirements would be stricter.

His warning was made at the 17th annual convention of the Oregon Feed and Seed Dealers' association. Among those elected to the board of governors were William Scarth, Salem, and President Duane Crabtree, Eugene.
