

# Spud Size, Grade Meet Slated Soon

A series of meetings for potato growers of the basin is scheduled to be held in the next few days for the purpose of discussing size and grade recommendations for the coming potato crop and for establishing a wage scale in the Tulelake area.

Officers and directors of the Klamath Potato Growers association and the Tulelake Growers will meet tomorrow night, Friday, September 9, in the office of C. A. Henderson, county agriculturalist, to discuss recommendations to be offered to the Oregon potato committee which meets the following Monday, September 12.

This session is scheduled for the office of Ross Aubrey, supervising federal-state shipping point inspector for the Klamath basin at 2237 S. 8th.

W. E. Huse, Tulelake, manager of the Oregon potato committee, in a statement issued today, says "the Idaho committee in a meeting held August 26 continued its present two-inch or four ounce minimum on Russet and white rose potatoes until June 30, 1950."

Huse urges that all potato growers and shippers under market order No. 59 be sure to vote for the new amendments. Important and beneficial amendments to Klamath and Deschutes county growers and shippers are incorporated in the new proposed order.

"Failure to pass this referendum by a two-thirds majority will result in a return to the old, inadequate and unworkable order," Huse said.

Growers and handlers on record will receive their ballots through the mail in the near future.

Third meeting will be held in the agriculture building at the high school in Tulelake, at 8 p. m. Wednesday, September 14.

This meeting for the Tulelake growers will be to establish the potato harvest wage scale for the Tulelake area.

# Heating Company Stocking Fuel As Winter Approaches

Enough hogged fuel for about four to four and a half months of operation is piled up now back of the Consumers Heating company plant on Klamath avenue, and more is being added to the pile every day.

John Meeryman, plant manager, said the estimate of the time the fuel would last was based on a "reasonable winter." The last one here wasn't reasonable.

The big pile contains about 13,500 units of fuel, supplied from various sawmills in this area. If the mills continue to operate until mid-December, Meeryman said, they probably will supply enough of the sawdust to last the winter and carry on over to next summer.

The central heating plant, with about 265 residences and business buildings as customers, is now using one boiler but will put another into operation with the advent of chiller weather.
