

Attack Kills Lum Frailey Of Tulelake

TULELAKE—A heart attack at 10:15 last night, took the life of Lum Frailey, prominent Tulelake rancher and long time resident of this community. He passed away at the family home four miles south of here on the Alturas highway. He was 83 years old.

Mr. and Mrs. Frailey came here in 1931, leasing land for farming and at one time farmed the present townsite of Tulelake. In 1938 they received the homestead in a reclamation land drawing where the family home now is and where Mr. Frailey was actively engaged in handling his land at the time of his death.

Prominent
He was a member of Tulelake post, No. 164, American Legion, of the Veterans of Foreign Wars and was affiliated with most of the farm organizations in this area.

While his health had not been good for some months his death was unexpected. He had been in Tulelake during the afternoon and had not complained of feeling ill.

Surviving are his wife, Mrs. Cordelia Frailey, Tulelake, two sisters, Mrs. William (Elizabeth) Bell, Dairy, Ore., and Mrs. Lulu Elmer, Minneapolis, Minn., a half sister, Martha May Frailey, Decatur, Ill.; and two brothers, Clarence Frailey, Yucipa, Calif., and Walter Frailey, Brentwood, L. I.

Max Naylor of Tulelake is Mrs. Frailey's son.

Mrs. Cora Ellen Culbertson, member of an old Klamath family, died at the age of 81 years at her home in Central Point Sunday. Mrs. Culbertson is the former Cora Ellen Swingle, daughter of Joseph and Ida Swingle who settled 100 years ago in Langell valley.

Mrs. Culbertson is the grandmother of Mrs. Troy Cook, 839 Eldorado, and the aunt of Mrs. Clara Collman of N. 11th street. She was born November 26, 1868, at Brownboro near Eagle Point while her mother was on a visit there. Her mother died at that time and Cora remained in the valley with relatives. The father left Langell valley some years later but is remembered by many old timers here. Joseph Swingle served in the MeDoc War.

Mrs. Cook and Mrs. Collman attended final rites in Medford and burial was in the old family plot in Central Point cemetery.

Woman Sues Meat Market

Margaret Watson, Fort Klamath cafe owner, has instituted a damage suit for \$10,000 against George W. Hanson, who has a meat market at the Piggly Wiggly store, 7th and Pine, and the Piggly Wiggly company.

Doctors' License Ruling Made

SALEM, Oct. 27 (AP)—The only doctors at state institutions who have to be licensed by the state are the superintendents and the assistant superintendents at the two state hospitals at Salem and Pendleton. Attorney General George Neuner ruled today for Governor McKay.

All other institution doctors can be unlicensed, Neuner said. McKay said he asked for the opinion because "the State Medical association has been giving me a bad time with their protests against the state hiring unlicensed doctors."

AP APPROVED

TOKYO, Oct. 27 (AP)—Zentel, leftist Government Communications Workers union, today reversed a one-day decision and voted to allow Associated Press reporters at its current convention. The AP was excluded from a ban against "unfriendly" Japanese publications.

3-Car Smash Injures Nurse

Mrs. Dorothy M. Ryan, 33, charge nurse at Klamath Valley hospital, started to work this morning in that capacity but wound up as a patient after a three-car automobile accident on the S. 6th viaduct.

Mrs. Ryan was being brought to work by her husband, Conrad Ryan, and as their car came up on the viaduct a locomotive below threw up a cloud of steam, forcing Ryan to halt his car.

Another vehicle, driven by Leonard Scott, 26, of 1314 Dayton, bumped into the rear of the Ryan vehicle. The two men got out to discuss the slight accident and Mrs. Ryan walked between the two cars.

Then a third vehicle drove onto the viaduct and smashed into the rear of Scott's car and pinned Mrs. Ryan between the first two vehicles, according to reports reaching city police. The accident occurred about 6:40 a. m.

Mrs. Ryan was taken to the hospital where her leg injuries were said to be painful but not serious. X-rays showed no broken bones.

In the haste, the full identity of the driver of the third car was not learned but Scott reported to police the driver's name was Nystrom, and had the license number of the car. A check of the number indicated it was registered to Ronald Nystrom, 37, of 904 Victory drive.

Traffic officers did not learn of the accident for several hours, and started an investigation.

Born in Norway
Mrs. Frankford was born Clara Olofson near Oslo, Norway, October 14, 1875. She had just recently observed her 74th birthday. She came to the United States with her parents at the age of 14, but her mother died while on shipboard in 1890 and was buried at sea, the father and children settling in Minneapolis.

Her first marriage was to Henry Thompson, in Los Angeles, and his death occurred December 16, 1914. She then married Frank Frankford of Klamath Falls, well known wood yard operator and business man. He preceded her in death several years ago.

Mrs. and Mrs. Dewey Powell are now in San Francisco, called there several days ago by Mrs. Frankford's falling health. The Frankfords left Klamath Falls after 20 years residence here, and Mrs. Frankford has lived in San Francisco for the past five years. She leaves many old friends here who regret to learn of her passing.

GI Dividends May Be Cut For VA Debts

WASHINGTON, Oct. 27 (AP)—The veterans administration said today it may dip into the forthcoming ex-GI life insurance dividend to collect up to \$30,000,000 (M) and that veterans owe the government.

"Somewhere between \$20,000,000 and \$30,000,000 of such debts may be collected from national service life insurance dividends," it said in a news release.

"All of the individuals concerned are aware of their indebtedness to the government and know that it is deductible from other VA payments to which they may be entitled."

The agency said around 600,000 veterans owe it about \$70,000,000 (M). The individual dividend payments will be sufficient to wipe out less than half of the total.

Most of the indebtedness consists of overpayments of subsistence allowance for veterans in colleges or training under the GI bill.

Other types of debt include defaults on loans guaranteed by government, overpayment of pensions, compensation or unemployment pay.

The \$2,800,000,000 (B) dividend is to be paid during the first half of 1950 to an estimated 16,000,000 veterans.
