Frigid Amphib Landing Success

OTTAWA, Nov. 17 (AP)—The navy reported today the successful conclusion of an amphibious landing exercise on Canada's Labrador coast in which specially-clad underwater demolition troops swam ashore through frigid water to make beach reconnaissances.

It was almost entirely an American show, Canada's representatives were the destroyer Haida, a unit of the support forces, and Canadian army officers who acted as observers with the task group consisting of 40 ships and 11,000 U. S. marines and sailors.

The landing exercise was held during the last 10 days of October and was the first of its kind held at high latitudes.

U. S. Saving Bond Purchases Down

Purchase of savings bonds in Klamath county in October totaled \$22,530, a decrease of \$117,000 compared to September, according to A. M. Collier, county savings bond chairman.

This downward trend followed that noted last fall in the state, when October sales also fell off considerably from September.

Redemptions, including maturities, nearly doubled the sales in October, with a total of \$47,512.
