Judge Raps Aged Man's Wife as 'Unscrupulous'

MINNEAPOLIS, UP—A probate judge says Michael J. (Mike) Kelley, one time minor league baseball magnate, is incompetent to handle his estimated \$500,000 estate and that Kelley's new wife is "an unscrupulous divorcee."

Judge James G. Kehoe, who Friday declared Kelley incompetent, appointed temporary guardians for Kelley and his estate and ordered that steps be taken to have the marriage annulled.

Mrs. Louise McDonald Kelley, 45, married the 70-year-old Kelley September 11 in a rushed ceremony, said through an attorney she may appeal the ruling to the state supreme court.

"UNSCRUPULOUS"
Judge Kehoe called Mrs. Kelley "an unscrupulous divorcee, with bottles of whiskey to feed him (Kelley) until he dies."

The judge held that Kelley "by reason of old age, loss, deterioration and imperfection of mental faculties, and excessive drinking of alcoholic liquor over a period of many years, is mentally incompetent to handle the charge and management of his person and estate."

He said Kelley "certainly needs the protection of the courts."

Kelley's latest will, made on September 10, the day before his marriage to Mrs. McDonald, was introduced in testimony during the guardianship hearing. It left everything but two \$1000 bequests to his wife.

In a memorandum attached to his order, Judge Kehoe said Kelley's drinking gradually increased after his first wife died last February. The judge said Mrs. McDonald started to associate with Kelley early last spring and soon proposed that Kelley make a will, marry her and adopt her daughter.

SWITCH
When Kelley's attorney, his chauffeur and his sister, Margaret, 31, objected, "Louise proceeded to clear them all out and employ another attorney who would go along with her in the matter," Judge Kehoe said.

Mrs. Kelley started the guardianship proceedings. A hearing on appointment of permanent guardians will be held October 19.

Kelley was prominent in the American Association baseball league for many years. He sold his Minneapolis team in 1947. It is now a New York Giants farm club.
