Woman Safe After Ordeal

FAIRBANKS, Alaska, (AP)—A Fairbanks woman, marooned on an icy river bed for two weeks, was safe today thanks to a grueling trek in rough, wild and frigid interior Alaska by her flier companion.

A daring rescue yesterday snatched to safety Miss Viola O'Brien only a few hours after her companion Bob Rouse, a Fairbanks construction forman, stumbled into an Eskimo village. He had started for help after the light plane carrying the two crash landed November 2. Rouse had made his way 35 miles through snowbound country to the village of Stony river about 250 miles west of Anchorage. Miss O'Brien was rescued by Bob Vandervel, veteran pilot from Alaska's Crooked river country. Vandervel landed his light single-engine plane on rough ground during a blinding snowstorm. The woman was flown back to Stony river where both she and Rouse were reported in good condition. Miss O'Brien survived her lengthy vigil despite inadequate food and clothing.

School Scraps Loyalty Oath

BERKELEY, (AP)—The University of California has scrapped its "loyalty oath" for professors and employees, subject of a dispute that has rocked the institution for two years.

The board of regents voted 12 to 5 yesterday against reviving the issue of whether all workers on the university's eight campuses should be required to state in writing they are not members of the Communist party. That made final the action of its October meeting—to eliminate the oath requirement. "Yesterday's vote was taken at the end of a discussion that was quiet in comparison to some of the bitter wrangling at regents' meetings since the oath was adopted in March, 1949. Seven regents were absent, including San Francisco Attorney John Francis Neylan—leader of the pro-oath faction—and Gov. Earl Warren—who had opposed the requirement. The resolution adopted in October and reaffirmed yesterday bans the special oath for future years as well as the current one. Its approval was greeted with this statement from the faculty's committee on academic freedom and signed by Ewald Grether, dean of the school of business administration: "The committee on academic freedom is confident that it speaks for the entire faculty in expressing its profound gratification with today's action. The oath was scrapped on the ground that since it was adopted a state law has been passed requiring all state employees to swear they are not members of subversive organizations. Firemen caught him in a life net, but he suffered head injuries when he struck a fire escape as he fell.

Police identified the man as Harold D. Demer, 55. They said they did not know why he jumped.

Grateful GI Goes Marine

ALBANY, N. Y., (AP)—A 22-year-old army veteran wounded four times in Korea has enlisted in the marine corps "because a marine saved my life under fire."

Duwayne St. John spent four years in the army, including the rugged fighting in Korea last winter.

He said a marine saved his life under fire and "I made up my mind on the spot that when I was discharged from the army I would enlist in the marines."

Trials Series Starts Monday

The first of six criminal trials slated in circuit court here in the next six weeks is scheduled to start Monday at 10 a. m.

Sanford Leroy Henderson, 31, Reedsport, Ore., will stand trial on a negligent homicide charge.

He is accused in the death August 31 of Mrs. Frank Hibbs, Jacksonville, Ore., of injuries received in a car accident on Oregon highway 66 25 miles west of Klamath Falls.

Henderson pleaded not guilty to the charge and is free under \$5000 property bond. He will be represented in the trial by Attorney U.S. Balentine.

OTI Winter Term Readied

Oregon Tech's winter term registration starts Monday and continues all week, Director Winston Purvine announced today.

Registrar Robert L. Smith reported today that all courses are open, and there will probably be no difficulty for prospective students wishing to enter classes of their own choice.

Director Purvine said enrollment was expected to be lower this term than a year ago because of the July 25 deadline on veterans entrance into training programs. At present veterans exceed non-veterans at the school by three to one. OTI, however, was one of the few colleges in Oregon to gain in enrollment this year. Most of them dropped.

Warren Proposes Middle Of Road Policy for GOP

SAN DIEGO, (AP)—Gov. Earl Warren of California has opened his campaign for the Republican presidential nomination with proposals that his party take a middle of the road course and support demands of the people for social progress.

In the initial speech of his campaign last night the 60-year-old governor declared that the Republican party has never been radical and must never become reactionary.

He said the party should stand for: Honesty in government; a bipartisan foreign policy; support of the United Nations; medical care on reasonable terms; slum clearance, and "the right of every segment of our society to a measure of security."

"We cannot stand still," the California governor declared in a talk of his campaign for the 1952 GOP presidential nomination.

"The Republican party has never been a radical party," he told delegates to the GOP state convention and a national radio audience. "It must not—as it values its life—become a party of reaction. It must occupy the field of activity between these two extremes."

Warren rested in a San Francisco hospital while a radio transcription carried his views on what the Republicans can do to appeal to the voters next year. He is getting a medical checkup for an intestinal disturbance.

SOCIALISM The 1948 Republican nominee for vice president, a three time governor in a nominally Democratic state, asserted that the American public is opposed to socialism—but not to social progress.

"They demand it," he said. "Without it our country would become decadent. Any party that turns its back on it will be repudiated by the people. We will face that issue next November. We

had better face it now." Warren added: "In saying this I am somewhat sensitive because I have been charged in some quarters with a lack of Republican conservatism for advocating some of those things, but I assure you I have not departed from our highest Republican authority—the platform."

The Republicans, he said, must pledge the voters rugged honesty in every phase of government.

CROOKS "We must clean out the chiseling, the favoritism and the dishonesty that is shocking the public today," he insisted.

Warren deplored use of reconstruction finance corporation loans to "bail out shaky enterprises" and to finance gambling houses. The RFO has been criticized for putting up money for a Reno hotel-casino.

The governor spoke of medical care on reasonable terms without calling it pre-paid health insurance such as he has unsuccessfully advocated in California.

On foreign policy, he said: "We cannot afford to equivocate between world cooperation and isolation. We cannot believe or practice both at the same time."
