Feed Grains Tilt Lower Today

CHICAGO, (AP)—Feed grains tilted lower while wheat and soybeans firmed in an active pre-holiday market on the board of trade today.

Buying in wheat came from both mills and export houses, as well as some of the larger local traders. The traders bought on news of a boost in the export price of wheat under the international wheat agreement, which will mean exporters can raise their buying prices for domestic wheat.

Wheat closed 1/4 cent higher, December \$2.59 1/2, corn 1/4 cent lower, December \$1.89 1/2, oats 1/4 cent lower, December \$2.01 1/2, soybeans 1/4 cent lower to 1/4 cent higher, November \$3.03 1/2-\$3.04 1/2, and laid 25 cents lower to 30 cents a hundred pounds higher, November \$16.92-\$17.03.

Trading Quiet On Stock Market

NEW YORK, (AP)—An irregular course was traced today by the stock market with trading exceptionally quiet.

After a higher start the market in the afternoon eased off in various areas until it presented a thoroughly mixed appearance.

There was about a 2-point spread higher for lower with the bulk of the issues only fractionally changed.

Trading came in an estimated 1,200,000 shares, as compared with yesterday's 1,120,000 shares, both also days.

The market put its best foot forward in some of the rails, steel, motor, and radio-television issues. The comparison, however, was a matter of degree.
