Xmas Tree Trade Brisk

Christmas tree dealers from points as distant as Seattle and Los Angeles have purchased nearly 19,000 trees from the Fremont national forest this fall, according to John E. McDonald, forest supervisor.

Many of the dealers come in July and August to search for areas where good trees can be found, and harvesting starts in late October. The trees which are harvested early are trucked out to points along roads at higher elevations, and removal to market is usually completed before December 1.

The white fir in this locality is particularly attractive to dealers because it has a slow growth rate which produces trees with short openings between branch whorls.

Free Christmas tree permits are issued by the forest service to any one who wishes to raise his own tree, or for trees which are to be used in schools, churches or other public service groups. Many people place their trees in buckets of wet sand, or in holders which will hold water to prevent the tree foliage from drying. This tends to reduce the danger of fires, but the danger of fire is always present when tree lighting is done, and light bulbs should not be left in contact with the needles.

Demurrer In Case Denied

Demurrers to a civil proceeding to test a job contract of Ervin M. (Joe) Searies with Cascade Laundry and Dry Cleaners have been overruled by Circuit Judge David R. Vandenberg.

The proceeding was brought by E. D. Isensee against Searies and his present employing firm, Superior-Troy Laundry. Dick Maxwell and Orth Blomere, attorneys for the defendants, demurred to Isensee's complaint, charging it did not show sufficient grounds for suit.

With the demurrers overruled, the defendants have five days, until early next week, to make formal answer to the complaint. Searies originally worked for Cascade, driving a laundry truck and soliciting work in the Merrill-Main-Tulelake area. A few weeks ago he terminated his work there and went to work for Superior-Troy on the same route. Isensee brought the court proceedings to try to enforce a contract he had with Searies, dated April 1, 1946, whereby if the latter's employment with Cascade was ended he would not solicit and pick up laundry and dry cleaning for a competing firm. Isensee, through his attorney William Kuykendall, asked a temporary injunction to halt Searies' work for Superior-Troy. Judge Vandenberg has not issued the injunction.

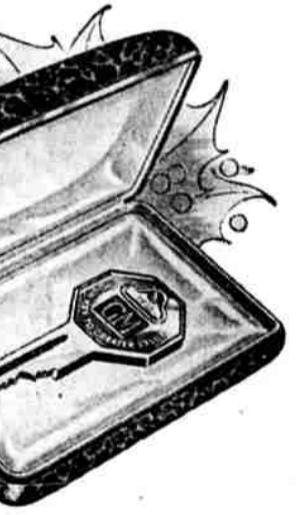
