

Hearing Asked WASHINGTON — Sen. Cain (R.-Wash.) has called for Congres-sional hearings on the Interior De-partment's proposal to link the Pa-cific Northwest power grid with California's Central Valley system. California's Central Valley system. Cain, a longtime opponent of the project, said Monday the hearings should be held here and in Wash-ington State. Cain said he felt "real concern" because President Truman, in re-questing funds for Pacific North-west water projects, had included a request for money for the Bonne-ville Power Administration and the Bureau of Reclamation to start construction of the power line. "My concern lies with the Presi-dent having implicitly made the decision that the inter-tie should be made." he said. 


