Truman Reveals Harrowing Threats of Old Residence

WASHINGTON (AP)—President Truman is getting pretty tired of delays in the rebuilding of the White House.
He wants to move madam and the baby—that's Mrs. Truman and Margaret—back into the mansion the first week in April.
The President's impatience was reflected Wednesday when he took White House newsmen on a 45-minute tour of the residential section, from which the Trumans moved shortly after his 1948 election victory.
EXAMPLES
He cited two examples of why the family had to take refuge in the Blair House, across the street on Pennsylvania Avenue.
He stamped his foot sharply on the floor of the sitting room of daughter Margaret's suite.
This will hold, he said. He recalled that one of the legs of Margaret's piano had broken through the floor in 1948, narrowly missing a drop into the family dining room below.
On another occasion, the President recalled with a grin, he was bathing when the tub in his own bathroom began to sink beneath him.
If it had dropped, he said, it would have fallen (with him in it) into the room below where Mrs. Truman often entertained guests.
KIDDING
He said he kidded the madam about what she would have done if she had been entertaining the Daughters of the American Revolution and he had suddenly appeared through the ceiling in a bathtub.
Mrs. Truman didn't think it too funny, he said, and told him he wouldn't have enjoyed the experience any more than she would.
It would have been a state entrance, he commented.
It was an exciting, if somewhat strenuous tour for the reporters, who had difficulty keeping up with the President's old Army pace of 120 steps a minute.

You find more things when you clean house. Been transferring files, and straightening up around the office, and I found a picture of Paul Harvey. Had a telephone request for Paul's picture, about two months ago, and I thought we didn't have it. So to the lady who called, here it is. "Paul Harvey" is the dramatic news commentator you hear every day at 1:00 and Sunday nights at 7:00. Harvey started in radio while he was still attending the University of Tulsa, Okla. Later, while on the staff of the ABC outlet in St. Louis, he was assigned to Hawaii to cover the U.S. Fleet's entry into the Pacific. While there, he reported the first blackout in American territory and the arrival of the fleet in port. His stories written, he returned to the U.S. on Dec. 5, 1941. Just two days later, the fleet on which he'd made his report, was the catastrophe of Pearl Harbor. . . . He has worked up to being ranked as one of the most popular of ABC's news commentators.
"I intend to make no move to obtain the nomination, if I am nominated in spite of myself, I shall not actively campaign." No, not Eisenhower, but another soldier once used those words—and became president of the United States. Edward Arnold portrays the president-elect during hectic days of his campaign in the "Mr. President" dramatization tonight at 7:00.
ABC's international news program, "Foreign Reporter," will report on the new optimism pervading the continuing negotiations at Panmunjom for a Korean Armistice, when Richard Rendell, ABC's Tokyo correspondent is heard from the Far East tonight at 8:45.
Music from Ireland, France, Sweden, Switzerland and Italy will be featured on tonight's "Concert of Europe," 9:30-10. These programs emanate from Paris and are heard each Thursday night on ABC. This has become one of my favorite musical programs—even like the theme music.
"Othello" is Saturday's Metropolitan Opera presentation. Featured as "Othello" will be Ramon Vinay. Eleanor Stever will sing the role of Desdemona.

EDITOR'S NOTE: This is the eighth of 10 stories explaining how to make our 1951 income tax return.

WASHINGTON (AP)—Here are some reminders on what to do, and what to watch out for, if you're making your 1951 income tax return on Form 1040-A or the 1040 short-form.

1. If husband and wife make a joint return, both must sign it.
2. Be sure when you hand in your return that you attach to it all the receipts—Form W-2—given you by a boss as proof of what he paid you and how much tax he withheld from you last year.
3. Be careful under item No. 1 on both forms, to claim all the exemptions to which you're entitled. For each you knock \$600 off your income before what's left is taxed.
4. Remember that Form 1040-A and the 1040 short-form can be used only for reporting income under \$5,000. If you're reporting more income than that, you can't use either of those forms. You must use the 1040 long-form where you figure your own tax.
5. Any under-\$5,000 person can use the 1040 short-form where you find your tax in the table on the back. But if you're under \$5,000 you can use Form 1040-A only if—
Full tax was withheld from your 1951 income except for no more than \$100 in untaxed wages, interest or dividends. If you don't fit that rule—most wage-earners do—but are under \$5,000, you can use the 1040 short-form.
6. Everyone using 1040-A or the short-form automatically gets a deduction of 10 per cent. It gets it automatically. He doesn't have to claim it or itemize it. It's allowed for in the table used to figure the tax on people using those forms.
7. If your income was under \$5,000 but your deductible expenses were more than 10 per cent, then use the 1040 long-form where you'll have to itemize but can claim your deductions in full.
8. Some points on Form 1040-A—
You do no figuring. Answer the questions. You pay no money when you turn it in, even though you think you owe tax. The collector will figure the tax for you.
If too much tax was withheld from you during the year, he'll give you a refund. If he finds you still owe tax, he'll notify you. You get 30 days after that notification to pay the tax.
9. If you file jointly on Form 1040-A with your wife, the collector will figure your tax both ways to see whether it's cheaper for you to file jointly or separately. He'll give you the benefit of what he finds.
10. Now take the 1040 short-form.
When you use the table on page 4 to find your tax, pay close attention to those columns which show the tax based on (1) your income and (2) the number of exemptions claimed on your return.
Say the Joneses, with two children, had a total income of \$4,835, of which his wife had earned \$35 sewing. If the Joneses file jointly, they claim four exemptions: Their own two and one each for their children.
On the line showing income from \$4,800 to \$4,850 Jones looks across to the column showing the tax on people with four exemptions. It shows—since his \$4,835 is between \$4,800 and \$4,850—that the tax on him and his wife is \$396.
But, since Mrs. Jones' income was more than \$600, she doesn't have to file a return at all, separately or jointly with Jones. But since she had some income, even though only \$35, he can't claim an exemption for her unless she files jointly with him.
Say she doesn't file jointly. That leaves him only three exemptions, for himself and the two children. And his income, minus her \$35, is \$4,800. He looks across that same line as before, the one showing the tax on \$4,800-\$4,850 income.
But this time he looks under the column for a married man with three exemptions—filing separately—and finds his tax is \$330 or \$134 more than his and his wife filed jointly, claiming four exemptions.
If you're a self-employed person using the 1040 short-form, note line No. 2 on page 1, where it says to list your Social Security tax, if you're self-employed.

Woman Backs Negro Family

EUGENE (AP)—White neighbors offered to buy a house to get a Negro family out of the district, the owner reported Wednesday. But the owner, Mrs. Effie Spencer, replied the house was under lease and option of sale to the Negro family.
That was the latest development in the case which Tuesday brought Mrs. Spencer a report that an anonymous phone caller threatened to burn the house down if the Leon Gasper family didn't get out before morning.
At the time, Mrs. Spencer said the Gaspers were proper people and she appealed to police. A patrol car reported no incidents.
Mrs. Spencer said that shortly before 1 a.m. Wednesday a phone call advised her to get out to her house quickly. Police took another look and found nothing.
Then, Mrs. Spencer said, she was told the neighbors met to discuss what to do about presence of the Gaspers, only Negro family in the district of relatively modest homes.
One of them said they would pay cash for her house, Mrs. Spencer said.
She said her answer was that she had been trying to sell the house and had given an option to the Gaspers. That, she said, blocked any other sale.

YIEKA POSTMASTER

WASHINGTON (AP)—The Civil Service Commission announced Wednesday that Donald J. Spurlock, Charles R. Orr and Martin H. Wohl Jr. are eligible for the Yreka, Calif., postmastership.
This year several million self-employed people pay a Social Security tax on their self-employment income for 1951. The tax is 2 1/4 per cent on the first \$3,600 of that income.
If you're in this group, list the tax on line 5 (B) and pay it, when you file the income tax return, together with any income tax you owe.
Besides using Form 1040 for their income tax return, the self-employed must also use a separate form, Schedule C, where they provide information necessary for determining their Social Security tax.
Many people filing on the 1040 short-form must use not only page 1 but page 2, also, because of their special income and problems. Because they find their tax in the table on page 4, they don't use page 3 which is strictly for those figuring their own tax.
