The federation met here Monday and denied reports that the federation might be changing its mind.

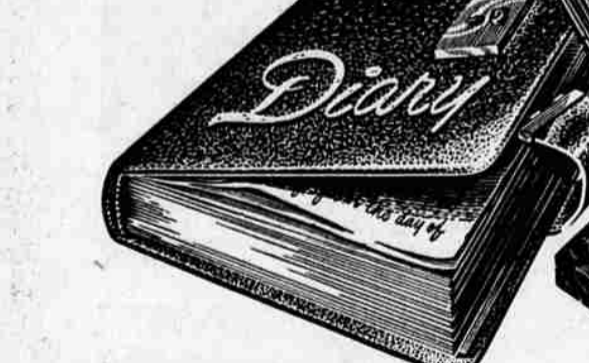
