Senator Urges Foreign Fund

WASHINGTON (AP) — Sen. Connally (D-Tex.) told the Senate Monday in advocating approval of a \$2,000,000,000 foreign aid bill that "a policy of timidity is a prelude to disaster."

As chairman of the Senate Foreign Relations Committee, Connally said the Mutual Security measure is probably the last major legislation he will pilot through the Senate before he retires next January. He did not elect to run again. The Texas senator argued in a pre-recorded Senate address against any further cuts in the authorization measure, trimmed by his committee one billion dollars below President Truman's request. The House has approved a \$2,162,000,000 ceiling on foreign aid.

Before Connally spoke, Sen. George (D-Cal.) told a reporter he will stick by the one billion reduction made by the committee on his motion, although he said he did not believe a cut to the House figure would damage the program much. A group of Republican senators has proposed additional slashes ranging from 500 millions to one billion dollars. Assuming that this country must be prepared to meet its Allies half way, Connally said that any delay of Congress to act decisively now "might mean that peace would slip from our grasp and the fruits of civilization would go out again for a long, long time."

He noted that three candidates for the Democratic presidential nomination — Sens. McMahon of Connecticut, Russell of Georgia and Kefauver of Tennessee — are backing the bill endorsed by the fourth candidate, Mutual Security Administrator W. Averell Harriman. Connally said he agrees American outlays should not threaten this nation's solvency, since he believes "if the American economy goes to pot, most of the world will go to pot with it." But he said the Russians know that isn't going to happen. "Indeed, their recent actions clearly indicate that the Russians are far more alarmed over the growing strength in Western Europe than they are encouraged by the deficit in our national budget," the Texas senator said.

Senator Sees Ike Following

WASHINGTON (AP) — Sen. Lodge (R-Mass.), campaign manager at Eisenhower for president headquarters, Monday interrelated Washington State's selections for Republican nomination delegates as evidence of rank and file demand for their candidate on the West Coast. His statement: "Opposition claims were again punctured when Republicans in the State of Washington named an Eisenhower delegation to the national convention."

Washington State Republicans elected 20 Eisenhower delegates and four Taft delegates. In a complete reversal of opposition claims that it would get 16 delegates. "Coming on the heels of the Oregon sweep for Eisenhower, this victory shows again that Eisenhower strength among rank and file Republicans on the Pacific Coast is as great as it is in other sections of the nation."

Taft Supporters Win Ground

MINERAL WELLS, Tex. (AP) — Taft supporters won the first round Monday as the State Executive Committee began screening competing county delegations to Tuesday's Texas state Republican convention. The executive committee voted 46 to 14 to seat a Taft-faction delegation from Jefferson County, thus turning down a rival delegation supporting Gen. Eisenhower. It was the first significant action by the committee on 31 contested county delegations to the convention, which will elect 38 national convention delegates.
