KUHS athletic insurance is to be handled by the student body from here on, with finances coming from the student athletic fund, it was decided at a joint session of the city and high school boards at the high school last night.

Next Tuesday night, a special meeting of an insurance committee is to accept bids for insurance covering liability, fire and theft from buses or trucks owned by the school districts.

The city school district (district No. 1) elected a half dozen teachers to positions here. The list included: Ethelyn Carter, Ball State Teachers, Indiana, who will teach at Pelican in music; Marilyn Haines, University of Oregon and Southern Oregon College, who will teach full time at Mills; Carl Long, SOC, who has not yet been assigned; June Potter, University of Nebraska, University of Wyoming and University of Oregon, who will teach full time at Mills; and the nuns, who will teach at Pelican.

Korean Talks Resume Today

MUNSAN, Korea (AP)—Korean armistice negotiations resume tomorrow after a fourth straight week-long recess.

The United Nations and Communist truce delegates will meet at Panmunjon at 11 a.m. (9 p.m., Tuesday, EST).

A fifth recess seemed likely unless a new approach is submitted on the deadlocking issue of prisoner of war exchange, last hurdle before an armistice.

Since July 26, the truce teams have met only once a week. At each session, both sides repeated their stands on the prisoner dispute. Then the delegates called it quits for another week.

The enemy wants back 116,000 prisoners, including all 20,000 Chinese in Allied camps.

The U. N. Command offers only 83,000 prisoners, including 6,400 Chinese. The U. N. says the remaining thousands of captives refuse to go back to North Korea or Red China. And the U. N. says it will refuse to use force to push any prisoner back across the line.

Catholics Get Morgan House

NEW YORK (AP)—A 57-room Long Island mansion, once a part of the J. P. Morgan estate, will be sold to an order of Roman Catholic nuns—instead of to the Russian delegation to the United Nations.

An agreement for the sale was worked out here yesterday by attorneys for the Russians, the City of Glen Cove, N. Y., and the nuns, the sisters of St. John the Baptist.

The Russians had tried to buy the house near Glen Cove. They paid from \$14,000 to \$15,000 for tax liens and offered a \$30,000 certified check to clinch the bargain.

But the City of Glen Cove, which acquired the mansion in 1949 for back taxes of \$5,232, returned the Russian check after some city residents protested against Russian occupation of the property.

Republican Leaders Discount Rumors of Rifts in Harmony

NEW YORK (AP)—Two Republican leaders discounted Tuesday the possibility of a "serious break" in the party and said they expect Sen. Robert A. Taft will give full support to Gen. Dwight D. Eisenhower's campaign for the presidency.

They were Sen. Styles Bridges of New Hampshire and Rep. Joseph Martin of Massachusetts, House minority leader.

Bridges and Martin conferred with Eisenhower at his newly established New York headquarters in the Hotel Commodore.

They said the conference was devoted to the progress and problems of the campaign.

Convention bitterness between the Taft and Eisenhower camps, they said, is not likely to affect the general's chances of winning.

"I think Taft's people, for the most part, are supporting Eisenhower enthusiastically," Martin said.

"I see no break in Republican ranks as far as Eisenhower is concerned. I am certain Senator Taft will be invited to join the campaign and will do everything he can."

Bridges, who was with Martin, agreed with him.

Bridges and Martin both said they felt the campaign is "on the up grade."

Martin called the outlook "very encouraging." He said he based his opinion on the size of the new Republican registration.

"There are always people who think a campaign is not going well," Martin said.

Reporters asked if he had heard the criticism that Eisenhower's campaign at this point has made little progress.

Bridges said he gave Eisenhower

a report on the possibility of the Republicans winning the Senate this year.

"With any sort of trend, we should be able to capture the senate with a two or three-vote margin," the Senator said.

Both men said they were certain that Eisenhower very soon will begin speaking out on the principal issues of policy.

Martin said he expected Eisenhower to emphasize "about a half a dozen" of the salient issues. He said there was not time enough to take up all of them.

The general's aides said a meeting with Taft himself is in the cards for some time next month. The date is still pending, they said.

From three different sources, Eisenhower apparently heard some frank talk about his campaign progress.

One was Sen. Wallace Bennett, of Utah, who supported Taft's drive for the GOP nomination.

Bennett said he discussed with Eisenhower the means of getting support from Taft's backers.

The senator added that he has found a "surprising number" of

independent voters who are in doubt now about Eisenhower, after having been sympathetic to his candidacy earlier.

Police Action Ends Second Big Brinks Theft

WASHINGTON (AP)—A hunch by Police Chief Robert V. Murray cracked a \$65,000 Brink's armored car theft Tuesday less than 24 hours after a 26-year-old bakery truck driver pulled it off.

Arrested and charged with grand larceny and bank robbery, was Ray Eugene Farmer, a short, slender youth who had been fired by Brink's three years ago after working as a guard for the armored car company.

All \$65,000 was recovered. Farmer dug up the money for police. He had buried it in a wooded area near Glen Echo Amusement Park in nearby Maryland.

It was a carefully planned robbery, sandwiched in on Farmer's bakery route Monday. Myrtle Jackson, receptionist at the bakery company, said Tuesday when advised of the arrest: "I just can't believe it."

"Ray came in from his route at the regular time Monday," she said. "He was just as calm and nonchalant as he could be. He was one of our best drivers, one of our most trusted employees."

RECOLLECTION—It was Chief Murray's recollection of a three-year-old incident led to Farmer's arrest. Murray recalled that Farmer's Brink's uniform once popped up in the hands of a tennage gang of hoodlums, rounded up on various charges.

There was suspicion at the time that some of this gang contemplated using the uniform in some sort of robbery.

Here is the story as told to reporters by Inspector Jeremiah Flaherty.

found in the possession of the gang in 1949, police took him into custody and questioned him. They found no evidence of any wrongdoing by Farmer and released him. Soon afterwards, Brink's fired Farmer because of the uniform episode.

He went to work for the bakery company. But, as it developed, he kept a duplicate key to an armored car which travelled in the same area of his bakery route.

LOCKED CAR—At noon Monday, the armored car pulled up to the fashionable Wardman Park Hotel and the four guards went inside to eat. They locked up the car.

Then Farmer drove up in his bakery truck, inserted his key,

turned the lock, grabbed a sack containing \$65,000 in small currency, pushed it into the bakery truck and drove off. He ignored \$300,000 in bills of large denominations.

It was several hours, however, before it was reported to police. First the company did a lot of back checking on the possibility there had been a failure to pick up a package of money earlier in the rounds.
