Eisenhower and Stevenson Faces Double Letter Jinx

How can either Dwight D. Eisenhower or Adlai E. Stevenson expect to win the presidency?

Neither one of them has a double letter anywhere along the stretch of their surnames.

And you have to go clear back to the days of Grover Cleveland to find a President of the United States who hasn't spelled at least one of his names with a double consonant or vowel.

Cleveland (his full name was Stephen Grover Cleveland) was president two terms, 1893-1897 and 1901-1905. Since that time, a full five score and six years, every chief executive has been a double letter man.

President Truman has his double letter in his first name, Harry. Before him there was Franklin D. Roosevelt, and before him Herbert Hoover.

Calvin Coolidge, also a double-letter man, held the office before Hoover and before him there was Warren Gamaliel Harding.

City Council Holds Action On Fluorides

The City Council last night postponed for a time any action toward making an official call for fluoridation of the Klamath Falls drinking water supply.

An ordinance asking the Oregon Water Corporation to add fluorides to the water was held up and City Attorney Henry Perkins is to re-write a part of it and submit the re-drawn ordinance to the company for its study.

Fluoridation is considered a method of combating tooth decay, particularly among children.

The step has been approved by the local and state medical and dental societies and Mayor Bob Thompson and members of the council apparently want to go ahead with it. The position of the water company is neutral. It will inject fluorides into the water if a majority of the public is in favor.

BOWEN

Glenn Bowen, manager of the water company, told the City Council last night that the public reaction he had noted so far is rather lukewarm. That in the past week he had received just two letters and five phone calls from persons objecting.

One of the adverse reactions came from a religious group, the Christian Scientists, who object to fluoridation on the grounds that it "constitutes state medicine."

Norman Dexter Scoville, of the Christian Science committee on publications, Portland, notified Mayor Thompson of the objection and wrote that if the medication of the public water supply is authorized for the prevention of tooth decay, it is entirely possible that this step could be the forerunner of medication for other ailments and diseases and that without in-depth diagnosis "this will be an unwarranted invasion of the realm in which each citizen decides for himself what remedies he uses."

The use of material medical remedies is opposed to the teachings of Christian Science.

OTHER ACTION

In other action last night the City Council:

Approved \$1,675 worth of building permits.

Agreed to abandon the proposed Pleasant Street paving job, at the request of property owners. The bid price of the job was considerably higher than estimates and higher than property owners wanted to go.

Instructed City Engineer E. A. (Taxi) Thomas to proceed as far as practical with the grading and rocking of the Rogers Street extension, new street being cut through from Rogers to Riverside, with a view to completion next year.

Approved the location of a trailer registration booth on Main Street, Sept. 29-Oct. 4, by the Junior Chamber of Commerce.

Requested the California Oregon Power Company to install new street lights on the newly paved portions of Painter, Lawrence and Lowell.

Introduced an ordinance forbidding obstructing borrow pits for driveway entrances and requiring the use of culvert pipe for such entrances.

Paper Asks Nixon Resign

PORTLAND (AP)—The Oregonian, in its lead editorial Tuesday, called for the withdrawal of Sen. Richard Nixon as GOP vice presidential candidate.

"In the first place... he would not have been given the nomination by the Republican convention had delegates known that he was the political beneficiary of a private fund of \$18,235 raised by California business and professional men," the editorial said.

"The Nixon matter is an embarrassment to the Republican presidential campaign in which Nixon is not an essential figure. Senator Nixon could well step out, allowing the Republican national committee to select a successor."

TRUMAN ASKS

Eisenhower Says HST Incompetent

ABOARD EISENHOWER SPECIAL (AP)—Gen. Dwight D. Eisenhower campaigning in the home state Sen. Robert A. Taft, declared Tuesday the Truman administration is "totally incompetent to straighten out the problems that face this nation."

The Republican presidential nominee, introduced by Charles Taft, Republican candidate for governor, told a crowd estimated at 3,500 persons at Middletown, Ohio, it is "a deliberate policy of this administration to deflate money."

It has taken as a slogan "inflation is the best policy," he declared. "The Republicans want honesty in the dollar."

Eisenhower said the GOP wants "big men" in office in Washington. "Not men who are too little for their jobs and too big for their heads."

INFLATION

The Republican nominee announced he will speak in inflation in a major address in Cleveland Tuesday night.

Eisenhower made no mention of the political suitability over his running mate, Sen. Richard M. Nixon of California.

He told the crowd people are "vastly disturbed" because the administration has not led the nation to peace. He said the failures of the Democrats to win peace have caused this worry to enter every home across the land.

Again he attacked the administration for its spending program and for "living beyond our means." He said "hideous mistakes" have been hidden.

"TOO LITTLE"

He said these troubles were caused by men too little for their jobs. He didn't doubt the courage and comprehension to come before the people and correct their mistakes.

And he said: "They even call a great war in Korea a police action."

Eisenhower called for a change of leadership in Washington — because "we can not have peace in the world until we have a revolution that can excite your pride."

Sports Group Sells Photos

Ducks Unlimited is on the march again. This time for more feeding area for ducks within the borders of the United States.

For many years DU, a non-profit organization of sportsmen formed to bolster the fading duck population, has been working away at improving the Canadian and Alaskan breeding grounds of the North American continent's duck population. These efforts have proven so successful that now there is a serious threat of inadequate feeding in this country for the myriads of ducks that will soon start their flight to Mexico and the south.

Surveys to date show that while some signs of migration have already started most of the duck and geese to date are from Alaskan areas, with the Canadian hatch still to come when weather starts them on their way. With a good increase in the numbers of ducks this year over the preceding few years the situation is alarming, according to DU representatives.

In a nation-wide drive to raise funds to secure this additional land DU has started a sale of duck pictures, now on display in Klamath Falls at the Gun Store and Poole's.

To be sold in sets of eight. Several of the color photographs were taken in this area.

The pictures are the idea of Walter Henne, prominent Klamath businessman and sportsman, and are the work of Mr. Johansen. They are 11 by 14 inch matted photos of ducks and geese in flight including mallards, pintails, snow geese, and wigeon.

10 California Counties Urge Trinity Diversion

Ten thirty counties of California's San Joaquin and Sacramento Valleys have banded together to ask Gov. Earl Warren to speed up approval of the proposed diversion of the flow of the Trinity River, thereby setting the stage for what might be one of California's greatest water fights.

On the other side of the fence, four Northern California and two Southern Oregon counties have joined together to ask the legislatures of the two states to set up an interstate commission to study the water resources and needs of the Klamath River watershed with an eye to protecting the watershed from diversion.

The Trinity is a tributary to the Klamath.

Meeting at Red Bluff last week, representatives of Shasta, Trinity, Tehama, Glenn, Butte, Tulare, Kings, Kern, Merced and Colusa counties declared that legislative approval of the Trinity diversion is essential for "realization" of the multi-million dollar Bureau of Reclamation project.

The diversion would be made in Trinity County, taking water out of that river and transporting it through tunnels and canals to the Sacramento River where it could be used in the counties of the great and populous agricultural valleys.

The counties against such diversion, which are preparing to ask legislative approval local policy making involving the waters of the Klamath watershed, are Siskiyou, Modoc, Humboldt and Del Norte in California, Klamath and Jackson in Oregon.

Diversion of the Trinity, as proposed by the U.S. Bureau of Reclamation, seemingly would have little effect upon Klamath County and the surrounding agricultural area, but might have an adverse effect on water-dependent industries and sports along the lower reaches of the Klamath. Also, the northern counties fear, it would be a foot in the door toward future and greater diversions which next would tap the Klamath itself and eventually other streams, such as the Rogue, Umpqua and Columbia.

At the Red Bluff meeting, Congressman Clair Engle (D-Calif.) said that he had "firm assurances from high Bureau of Reclamation officials in Washington that money will be requested for the next budget to begin construction if the report is approved by the State of California."

Rep. Engle's district includes 18 California counties (Alpine, Amador, Calaveras, El Dorado, Inyo, Lassen, Mariposa, Modoc, Mono, Nevada, Placer, Plumas, Shasta, Sierra, Siskiyou, Tehama, Trinity and Tuolumne).

Adlai Admits Money Deal In Illinois

CHICAGO (AP)—A charge by an Eisenhower supporter that Gov. Adlai E. Stevenson promoted a cash fund from private individuals to augment salaries of some state officials was admitted by the Illinois governor last night.

But, the Democratic presidential candidate said, there was nothing secretive or improper about such aid.

Stevenson, in a statement in New York, said there never has been any secret about his trying to ease the financial strain of men he intends to leave private employment to take state jobs. None of the men, Stevenson said, was an elected official or an office seeker.

The governor's statement was in reply to a charge made by Kent Chandler, a Chicago manufacturer, in a telegram to Stevenson that he personally promoted a cash fund, made up of contributions from private citizens.

SERVED IKE

Chandler, who served on the Citizens for Eisenhower Committee before the Republican convention, said in his telegram that the fund "was paid to various of your official appointees to state jobs in order to supplement the salaries paid them by the state."

He asked Stevenson to disclose the names of the contributors and recipients and the amounts involved. Chandler said the governor had made known he favored such an assistance policy to him and others at the Chicago Commercial Club last April 23. Stevenson said last night he did not recall any such conversation with Chandler.

Stevenson, who is in his first four-year term as governor, at that time had announced his candidacy for re-election.

In his statement, Stevenson said, "there never has been any secret" about his views on such aid to state officials and that they entered public service at his urging and at personal sacrifice to themselves.

NO INFLUENCE

"There is no question of improper influence because there was no connection between the contributors and the beneficiaries," the governor's statement said.

He said the funds were left over from the 1948 campaign for governor, plus later general contributions.

The main points worked out by Lewis and Moses, other than the wage and royalty increases, provide:

New Commie Pacts Seen

MOSCOW (AP)—Sweeping new economic arrangements between Soviet Russia and Communist China appeared likely today in the wake of Chinese Premier Chou En-lai's departure for home after Kremlin talks with Prime Minister Stalin.

Chou flew off to Peking yesterday, but left behind eight members of the delegation that accompanied him here for the conversations—including several of his top men in the economic field.

These could be remaining behind to iron out such details as delivery dates and perhaps credit agreements on any new trade pact.

Speaking to a farewell crowd at the airport, Chou declared that during his delegation's stay in Moscow "we successfully completed talks concerning important political and economic questions between China and the USSR."

Promises Full Report On Finances

LOS ANGELES (AP)—The Republican candidate for vice president steps before a jury of Americans by the millions tonight to tell his story of an \$18,000 expense fund and to plead for vindication.

The verdict of those who hear Sen. Richard Nixon of California in his fateful half hour radio-television broadcast may decide whether he will remain on the GOP ticket with Gen. Dwight D. Eisenhower.

Associates of his interrupted campaign denied emphatically there was any basis for talk that he would resign.

They said he will try with all his heart to convince the country that he did no wrong in accepting contributions from wealthy California friends to pay for "strictly political activities."

NBC television and two radio networks—CBS and MBS—will carry Richard Nixon's speech which will be carried on Mutual network (KFI) in Klamath Falls tonight from 8 to 8:30 Daylight Time (7 to 7:30 Standard Time).

The unprecedented explanation from 8:30 to 7 p.m., PDT (8:30 to 7:30 EST).

PROMISES

Nixon promised he would tell everything about both his personal and political finances. He planned to speak from the NBC television radio without a prepared text. There will be a supplementary press statement listing private income and expenditures described as too detailed for the limited air time.

Eisenhower said yesterday he will decide whether to retain his young running mate after Nixon's public report. Dispatches from the Eisenhower campaign train declare the general is known to have said that Nixon must come "clean as a hound's tooth" in his financial history.

It has been Nixon's steadfast contention that none of the disputed fund went into his own pocket. He said that none of the contributors ever asked for or received any special consideration from him.

CRITICIZED

Democrats and some Republicans criticized use of outside money by a senator, and Eisenhower strategy leaders became concerned that the outcry would embarrass his campaign attack on corruption in Washington. Nixon replied that he was never asked for or received any special consideration from him.

He said the funds were left over from the 1948 campaign for governor, plus later general contributions.

TIED

Nixon looked tired. There is no question that the ordeal of the past week and the chilling possibility of being dropped from the GOP ticket have been a severe strain for both Nixon and his slim, blonde wife Patricia.

A high-ranking member of his staff declared privately that Nixon was "sick" over the fund raised by the \$18,000 but added firmly there was no talk of a resignation.

Nixon went into seclusion in his hotel room to assemble data for his broadcast. First, however, he took a dip in the hotel swimming pool at his doctor's suggestion.

Dr. Hugh Prichard of Nixon's campaign staff said, "We want him to get in good shape" for his speech.

TIGHT-LIPPED

Nixon remained tight-lipped on his status with Eisenhower—that is, if he knows it himself.

At the airport he was asked for comment on the fund-raising decision. He climbed up on the hood of a car with his wife and said:

"I've got to talk to the people."

"To the crowd clustered around him, he said:

"Patricia and I just want you to know how wonderful it is to get back and get such a fine welcome from our friends."

"We want you to know we have received thousands of wires from all over the country and we are grateful for them, particularly from the people we know."

"This is a time when you find out who your friends are."

"I think you want you to know we won't let you down."

NEW YORK (AP)—The New York Times said today the administration is "studying the application of a criminal statute that might be used against Sen. Nixon" and the contributors to his \$18,235 expense fund.
