Livestock

CHICAGO (AP)—Hogs sold nominally steady Saturday at the best prices since mid-October. Cattle and sheep also were quoted nominally unchanged. With receipts here and at other marketing centers down about 20 per cent from a year ago, and with an improved dressed pork trade, hogs climbed throughout the week. Gains ranged from 75 cents to \$1.25 with heavy weight hogs showing the best upturn.

Most sections of the cattle market also were higher for the week even though the available supply was somewhat larger than in the comparable 1952 week. However, choice and prime steers were only steady. The percentage of cows among receipts increased.

Heavier weight slaughter lambs sold off about \$1.00 but good to time hogs weighing less than 100 pounds jumped .00 to \$1.50. Sheep held steady to 50 cents higher.

Ike Lauds Dewey; Hints More Service

By MARVIN L. ARROWSMITH NEW YORK (AP)—President-elect Eisenhower said last night that Gov. Thomas E. Dewey's greatest service to his country still lies ahead. Eisenhower's pat on the back for the New York governor, who was defeated for the presidency in 1944 and 1948, came at a public dinner last night at which Dewey also was present. The President-elect may have been talking in only general terms which possibly had no special significance. On the other hand, Eisenhower's remark touched off speculation that: 1. He may be thinking of urging Dewey, who will be 51 in March, to bid again for the presidency some time in the future. 2. He may be hoping that Dewey will accept an important post in the new administration when his term as governor expires at the end of 1954, or possibly sooner. If Eisenhower had either point in mind, it could cause resentment among some Republicans who reportedly already feel that Dewey is wielding too much influence in the new administration. The Manhattan dinner at which both Eisenhower and Dewey spoke last night was the kick-off of the American and New York Heart Associations' drive for 10 million dollars to fight heart disease. Dewey spoke first and made a fervent appeal for funds for the program. Eisenhower, talking without notes, also praised the program. Then he turned to Dewey who was seated close by and declared: "If you had spoken in 1948 like you spoke tonight, governor, you couldn't have been licked. And I don't think you were."

Eisenhower next made an obvious allusion to Great Britain's 78-year-old Prime Minister, Winston Churchill, with whom he conferred earlier this week. "I spoke to a man the other night who is 77 or 78 years old—one of the world's leaders," said the President-elect. And I said to him: 'Isn't the time coming when you should retire more in the background and come out with your heavy artillery more when you are needed in a crisis—but letting somebody else carry on the day-by-day battling?'" "And he looked at me and said: 'Not at all. My opportunity for my greatest service to my country still lies ahead.'"

Then Eisenhower turned to Dewey and said: "And that same thought in my mind certainly applies to you, Gov. Dewey."

Dewey has said he does not intend to run for the presidency again. He also has said he will not seek another term as governor. Shortly after the Nov. 4 election, Eisenhower and Dewey conferred at Augusta, Ga. After the session, Eisenhower issued a statement saying that Dewey's insistence on serving out his term as governor precluded, at last time, his accepting a post in the new federal administration. The statement indicated that Eisenhower was hopeful then that Dewey later on would be available for a post. And the general said Dewey had promised to accept temporary emergency assignments in the meantime, if the occasion should arise. Eisenhower's prediction last night that Dewey's greatest service to his country lies ahead was made against a background of new dissatisfaction on the part of some Republican senators about the way the incoming administration is handling job patronage. The patronage assignment is being handled by Herbert Brownell Jr., long a Dewey lieutenant, who will be attorney general in the new administration. Sen. Robert A. Taft, who was Eisenhower's chief rival for the

from McKay on what stand he would take when he became interior secretary. The A.P. reported McKay refused to comment. Numerically, those who want the homesteading policy continued appear to be far outnumbered, so far as the top brass in Washington are concerned. Such organizations as the Isaac Walton League and other sportsmen's groups have formally requested that the land be turned over to Fish and Wildlife.

Why then does Fish and Wildlife want control of the land? Tom Horn, manager of Fish and Wildlife's Tulelake Game Refuge, says the principal reason is that it will assure hunters of a place to hunt. He argues that homesteaders might post their land to such an extent it greatly curtail the sport. Ranchers and some sportsmen battle that argument. They say there have been few homesteaders closed to hunting and there is no reason to think new homesteaders would increase the practice.

Another argument concerns economy. Would an agriculture economy based on year-to-year leases be as solid as one based on privately owned farms? On the economy angle, it is important to note that Fish and Wildlife does not propose to in any way curtail the land's production of money crops.

The 6,700 acres which Interior Secy. Chapman has ordered homesteaded is comprised of 4,200 acres in the Klamath Straits tract in Oregon and the entire League of Nations tract in the Tule Basin. The order would leave about 1,770 acres in Oregon adjacent to the California line for Fish and Wildlife, apparently done with the intent to assure public shooting ground for Oregon hunters.

Telegram Case To Grand Jury

SEATTLE (AP)—John E. Thomas, 42, charged with impersonating a federal official in attempting to delay the execution of Utah and Turman Wilson last week, was bound over to a federal grand jury Friday. Thomas, a Seattle furniture dealer, is charged with sending a fake telegram bearing a name similar to that of Sen. Magnuson (D-Wash.) to the Washington State penitentiary shortly before the Wilsons were hanged for the 1950 murder of John Dewey at Vancouver. The telegram was received by prison warden John Cranor a few minutes after the Wilson brothers were pronounced dead. The telegram caused a flurry of excitement at the prison until it was learned Magnuson was not the author.

Smith Named To State Dept.

NEW YORK (AP)—President-elect Eisenhower announced Saturday the appointment of Gen. Walter Bedell Smith as undersecretary of state and of Lloyd A. Mashburn, California Labor Commissioner and AFL union member, as undersecretary of labor. Smith, 57, now is chief of the Central Intelligence Agency. He was secretary of state in Eisenhower's chief of staff in Europe and later as Ambassador to Moscow. Eisenhower headquarters said Smith is retiring from active service in the Army to serve as undersecretary of state in the new administration. Mashburn, 55, was appointed in 1951 by Gov. Earl Warren of California as chief of the division of labor law enforcement in the state's department of industrial relations. By California law, the man holding that office is also the state's labor commissioner. Mashburn is a member of the AFL International Union of Wood, Wire and Metal Lathers, Local 42. Gen. Smith served from 1923 to 1929 as an assistant Budget Bureau director. Later he was deputy chief coordinator and vice chairman of the Federal Liquefaction Board.
