Rosenbergs' Boys Into Seclusion
TOMS RIVER, N.J. (AP) — The children of Julius and Ethel Rosenberg, who were executed Friday night, as atom spies, have been taken into seclusion by the family friends who are caring for them.

Bernard Bach, owner of the farm where the boys have been boarding, left with them shortly before their parents were electrocuted in Sing Sing prison at Ossining, N.Y.

Bach did not say where he was going with the sons, 10-year-old Michael and Robert, six, or when he would return. A member of the family at the farm Saturday said she could say nothing further.

Michael Rosenberg knows his father and mother were executed, but Robert was not told immediately.

Michael heard an afternoon news bulletin which interrupted a television broadcast of a baseball game. The bulletin said the warren of Sing Sing told reporters to be at the prison at 6 p.m. (EST.)

Michael said "that's it." Bach reported, "Good-bye, Good-bye."

Bach said he would break the news to Robert, who did not hear the news bulletin, "in easy stages."

Ike Recalls Raise-Less Army Days

WASHINGTON (AP) — President Eisenhower Saturday recalled the good old days when the dollar bought more of the necessities of life.

In signing a bill raising the pay of Washington police and firemen an average of 12 per cent, he told a group of onlookers in his office that it was plenty tough trying to get raises for the Army years ago.

"As a matter of fact, he said, Army men went without a raise from 1908 to 1935. He apparently referred to within-grade raises and meant Congress had not increased pay for the various ranks during that time. Eisenhower graduated from West Point in 1915.

It was really hard going in those days, he said, "as a matter of fact I had more money then than I ever had since."

Reds Demand Special UN Session Seen

UNITED NATIONS, N.Y. (AP) — U.N. sources said Saturday Secretary General Dag Hammarskjold S. Pearson may decide to call a special assembly session if a Korean truce is not concluded before they meet next week.

The two top U.N. officials are scheduled to meet next Wednesday or Thursday in either Ottawa or Toronto, since Pearson, Canada's foreign secretary, is campaigning for the coming general elections there and can't get away.

U.N. sources said the Secretary General probably would oppose a special Assembly session. A spokesman for the American U.N. delegation said, however, the U.S. has not been consulted on a possible meeting.

Western sources said they understood the truce was scheduled to have been signed Monday, Korean time (Sunday in the U.S.), but that South Korean President Syngman Rhee's release of anti-Red POWs upset that date completely and it was not known when the armistice would come.

Truman Doesn't Backtrack On Rosenberg Stand

DECATUR, Ill. (AP) — Former President Harry Truman moved out to Decatur Friday with his wife, Bess, and offered a brief comment on the execution of Julius and Ethel Rosenberg.

"My actions in the Rosenberg case speak for themselves," Truman said to a newspaper. He declined to elaborate.

The former chief executive stopped overnight while traveling "inognito" from Independence, Mo., to Washington.

During his last months in office, he was asked to spare the lives of the Rosenbergs by granting them an executive clemency. He did not act in the matter before turning over his office to President Eisenhower.

The Trumans plan to reach Washington next Monday for their first visit since they left the nation's capital last November. They are traveling alone and Truman is driving the family auto, a 1953 black Chrysler sedan.

Conviction Brings Hawaiian Strike

HONOLULU (AP) — Dock operations at all Hawaii ports were brought to a standstill and five sugar plantations were shut down Saturday by a union walkout protesting conviction of their leader.

Jack Hall, island head of a independent Longshoremen's and Warehousemen's Union, was among seven persons convicted Friday of conspiring to teach and advocate violent overthrow of the government.

Some 2,000 union stevedores and 1,000 sugar workers so far were involved in a walkout which began less than an hour after a racially-mixed, all-male jury returned the verdict.

South Korea Demands All POWs Freed

SEOUL, Sunday (AP) — Up to 300 more anti-Red Korean prisoners broke out of a stockade late Saturday night at Sang Mundal. This raised to more than 26,000 the total who fled the stockades since Wednesday midnight with South Korea's blessing.

The Reds, charging that South Korea's defiance of the U.N. command threatened the impending truce, has demanded that all escaped prisoners be rounded up. Friday night emphasizing the near hopelessness of the task, the U.N. command said only 68 had been released since 8 a.m. Thursday.

The 58 were in addition to 971

rounded up quickly between Wednesday midnight and dawn Thursday at the height of the mass breaks.

The U.N. prisoner of war command said the breakout at Sang Mundal began about 11 p.m. and that those fleeing totolled between 200 and 300.

"Reports from the camp at 12:30 this morning indicated that all was quiet following the break," a POW command spokesman said.

South Korea's acting Prime Minister demanded that Gen. Mark Clark immediately release some 9,000 anti-Communist Korean prisoners still in Allied stockades because we "must liberate them all."

And the U. N. commander today

released a scathing letter accusing South Korea's fiery President Syngman Rhee of breaking a "personal commitment" not to take unilateral action with I.O.K. forces in the U. N. Command.

Clark called the release of almost 26,000 anti-Red prisoners on Rhee's orders this week "precipitous and shocking."

Rhee and his cabinet met this morning to study a stinging rebuke from President Eisenhower and government sources said the Cabinet might discuss Rhee's answer. Eisenhower accused Rhee of violating U. N. Command authority in ordering the prisoners freed.

Forty-five more anti-Communist Koreans fled from three U. N. prison camps Friday night and early Saturday. The U. N. Prisoner Command said nine were recaptured.

One South Korean was killed and one U. S. soldier was wounded at a camp near Pusan.

South Korea's Acting Prime Minister Yung Tai Pyun, in a letter dated Thursday, demanded that Clark turn over all anti-Red prisoners still in Allied hands.

"We must liberate them all, preferably . . . in a manner less likely to cause trouble," he said.

And Pyun warned:

"I should like to call your attention to the mutual need of refraining from saying or doing anything that might likely provoke passions of the (Korean) masses, which once let loose may easily go out of control. If there is any talk to be done, it had better be managed quietly, we believe."

Pyun's letter, written after the mass escape of about 26,000 prisoners early Thursday, said: "We regret very much that several scores of prisoners were killed and injured by United Nations guards."

About 26,000 anti-Red prisoners fled from seven U. N. camps Thursday night and Friday night. South Korean guards, acting on orders of President Rhee, turned their backs as the prisoners escaped.

Clark told Rhee in his letter, released in Tokyo, that he could "not at this time estimate the ultimate consequences" of Rhee's action in releasing the prisoners.

The U.N. commander said he was "profoundly shocked" by this unilateral abrogation of your personal commitment, which was so freely and voluntarily given . . . that you would not take unilateral action with reference to ROK forces under my control until after full and frank discussion with me.

Clark said he could not estimate the "effect on the common cause for which we have sacrificed so much during these past several years."

Four marching throngs of Koreans paraded through Seoul's downtown streets, celebrating release of the prisoners. Korean civilians have been ordered by their government to hide and feed the prisoners.
