Korea's Red Boss Swinging From Russia; Purge Possible

TOKYO (AP)—Korean sources indicated today Marshal Kim Il Sung, the fat boss of Red Korea, is swinging away from Russia and toward closer ties with Red China—even as contradictory reports

said Kim himself had been purged. There was no way of checking the rumors, but it appeared that political unrest gripped North Korea.

Kim reportedly has been turning out Korean Reds who lean toward Russia and boosting party members who put Communist China first.

At least three members of Kim's Cabinet were reported purged: Foreign Minister Park Hun Yung, Justice Minister Lee Sung Yup, Vice Premier Hu Ka Wee.

All are Koreans. Communist jail after being purged three months ago. He was formerly head of the Communist party in South Korea until his defection to the North in 1946.

What happened to the other two Cabinet members was hidden behind the Bamboo Curtain and the mists of war.

In Seoul, South Korean Home Minister Chun Hun Shik said intelligence reports received there indicated Kim, whose real name is Kim Song Ju, is throwing out Red Koreans favoring Russia and backing Korean Communists favoring Red China.

It was confusing because other Korean sources said Park Hun Yung favored Red China and this stand cost him his job. There was no way to reconcile the conflicting reports.

Home Minister Chun Hun Shik said the chairman of the North Korean Peoples Supreme Committee, Kim Tou Bong, had won the favor of Marshal Kim.

There were other reports that Marshal Kim, whom the South Koreans call an impostor, was close to Lavrenty Beria, the deposed secret police chief of Russia.

South Korean intelligence sources said they did not know whether Kim had any close connection with Beria.

There were still other reports that Kim Il Sung had been given the ax in North Korea and would be at Panmunjom to sign a Korean armistice, if one is arranged.

However, the last report seemed doubtful because Gen. Mark W. Clark's headquarters in Tokyo has had signed truce communications bearing the name of Kim Il Sung in recent weeks.

Under the law creating the commission, eight additional members will be designated by Congress.
