CHICAGO LIVESTOCK — CHICAGO — Trading in live hogs had mixed reactions Friday to an overrun of around a thousand head. Butcher weights were strong to 25 cents higher but sows fell 25 to 75 cents.

Cattle ranged from steady to 50 cents lower and veal calves turned weak to \$1.00 off. Sheep were strong to 75 cents higher.

Almost all barrows and gilts sold within a range of 15 cents a hundred pounds at \$20.00 to \$20.75. Several loads did merit \$20.85 as a top. Sows took \$17.50 to \$19.00. A load of mostly prime steers sold at \$28.00 but most offerings in the class were good and choice at \$19.50 to \$25.25. A few good and choice heifers brought \$18.00 to \$22.00.

Choice and prime woolled lambs brought \$21.00 to \$22.00, highest since Oct. 5.

Salable receipts were estimated at 8,000 hogs, 1,500 cattle, 300 calves and 800 sheep.

Rural Health Uplift Group Selected

The need for a long-range health program in Klamath County was recognized at a meeting Thursday night of representative groups at the Klamath County fairgrounds, called by Mrs. Earl G. Kerns, health chairman, Klamath County Farm Bureau and Mrs. William Drew, chairman, county committee, Home Extension.

As a result, a committee of five, headed by Dr. William G. Holford Jr., representing the Klamath County Medical Society and including Mrs. Virginia Dixon, executive secretary, American Red Cross, Mrs. Leland Cheyne, representing the Klamath County Farm Bureau, Everett D. Perry, Klamath County School District and Dolores Bracken, home extension agent, were appointed by Mrs. Kerns to work with Mrs. James Luxford, Oregon Farm Bureau's representative on the Oregon Rural Health Council, on a proposed program planned to improve the health of farm families.

This group, functioning independently of the organizations they represent, will study formation of a Klamath County Health Council and will report findings at a future meeting.

Here for the meeting were Dr. Richard Wilcox, Oregon State Board of Health, and Margaret Warner, health education specialist, extension service, Oregon State College, who covered backgrounds of work of the Oregon State Council and similar groups operating in Indiana where Miss Warner was associated with health projects.

Mrs. Luxford defined the difference between demands and needs in the work of a health council and gave other information pertinent to use subject.

It was determined during the meeting that Klamath County has definite health problems and it is the purpose of a health council to seek out such problems and act in cooperation with other agencies to correct them.

Dr. Seth Kerron, Klamath County health officer, spoke favorably on formation of such a council and stated that he would welcome assistance on problems that confront him.

Favorable reactions to others present from several localities in the county were voiced.

Similar councils to the one proposed here are operating successfully in other counties in Oregon.

State Police Catch Escapée

Oregon State Police last night apprehended Tillman Donald Wharton, alias Jack Burton, an escapee from the Santa Clara County Jail where he was serving a sentence for burglary.

According to arresting officers, they were notified by a motorist while at Diamond Lake Junction, that a car driven by a drunk was on the highway nearby.

Investigating, the officers took into custody Wharton and a companion, Ernest Drexel Peters. They were driving a new 1953 Dodge 3-door sedan, reportedly stolen from the K. B. McCarthy new car lot at Eureka Wednesday. The car was not licensed but a set of stolen Oregon plates were found under the seat.

The two men told State Police that Wharton had picked up Peters while passing through Klamath Falls and that he had no part in stealing the automobile.

Later reports from Medford disclosed that Wharton had given the Skeeters & Skeeters Garage there a bad check for \$16.26 in payment for a tow bill, gas and labor.

Both men were returned to Klamath Falls and placed in the county jail, Wharton is charged with larceny of an automobile and being drunk on a public highway, while Peters was charged with being drunk on a public highway.

Jurisdiction Parley Slated

SALEM (U.S. Atty. Gen. Robert Thornton said Friday he had tentatively scheduled a conference here Monday with the federal district attorney and the Klamath County district attorney on the question of jurisdiction over Klamath Indian reservation crimes.

A Klamath Circuit Court hearing was recessed earlier this week by Judge David R. Vandenberg who told Dist. Atty. Frank Alderson to confer with the attorney general.

The attorney of a Klamath woman charged with murder contends the tribal council has jurisdiction. The federal government recently relinquished its jurisdiction and the state's position is that jurisdiction then passed to it, rather than reverting to the tribal council.

U.S. Dist. Atty. Henry Hess said in Portland that he would attend the meeting personally. He said there were a number of matters to look into, including whether a treaty right was involved.

In the recent congressional act, the Warm Springs Indians were excluded and the federal government kept jurisdiction. Hess said, because the Warm Springs Indians wanted it that way.

National attention was drawn to the jurisdictional battle here in the case of Gloria Wilma Barkley, Klamath Reservation Indian, charged with slaying her mother, when Circuit Judge David R. Vandenberg questioned the state's right to try her.

After listening to arguments for four days by District Attorney Alderson and Defense Counsel J. C. O'Neill, Judge Vandenberg abruptly halted the proceedings. He said offer any proof that the state had the district attorney had failed to confer with the U.S. attorney jurisdiction. He advised Alderson and the Oregon attorney general.

The court pointed out that a great deal more than the case before the court was involved.

Attorney O'Neill contended that when the federal government relinquished its right to prosecute certain crimes against Indians, including murder, the power reverted to the Indian tribal council. O'Neill also stated that under the Treaty of 1870 between the Indians and the federal government, the tribes were dealt with as a sovereign nation. Therefore, he added, any authority over the tribes relinquished by the government reverts to the tribes, not the state of Oregon.

On June 22 shortly after his trial started, Circuit Judge David R. Vandenberg told the jury that he did not believe the prosecution had sufficient evidence to convict Gaymon and the court also was of the opinion that the indictment returned by the Klamath County Grand Jury was faulty.

Gaymon Again Grabbed By Arm Of Law

The well-known "arm of the law" Friday again had Charles Gaymon Jr., tried last summer for murder, in its grasp.

Police reported Gaymon was involved in a fracas Thursday night at 630 Market St. and was badly beaten before he was taken into custody. He was charged with disorderly conduct.

Gaymon entered a plea of not guilty when arraigned Friday morning before Police Judge Frank Blackmer. A hearing was set for 4 p.m. Friday. The defendant is held in the City Jail in lieu of \$50 bail.

Last summer, Gaymon was the central figure in one of the most unusual murder trials in the history of Klamath County. He was charged with the knife slaying of Willie Watson, Klamath Falls garage worker.

On June 22 shortly after his trial started, Circuit Judge David R. Vandenberg told the jury that he did not believe the prosecution had sufficient evidence to convict Gaymon and the court also was of the opinion that the indictment returned by the Klamath County Grand Jury was faulty.

Four days later in the midst of the trial Judge Vandenberg dismissed the second-degree murder count and ordered the prosecution to proceed on a charge of manslaughter. The judge added that he did not believe there was even sufficient evidence to convict the defendant of manslaughter.

When the case finally went to the jury, a not guilty verdict was returned after 35 minutes of deliberation.
