Sale of timber, Klamath Indian Reservation. Sealed bids in duplicate on forms provided, therefore, marked outside, "Bid Fuego No. 1 Logging Unit," addressed to the Superintendent, Klamath Indian Agency, Klamath Agency, Oregon, will be received until 1:00 p.m., Pacific Standard Time, March 1, 1954, and will be considered the equivalent of oral auction bids and not guaranteed, of approximately 48,500,000 ft. B.M. of ponderosa pine, 1,195,000 feet B.M. of sugar pine, 200,000 feet B.M. of lodgepole pine, 10,000 feet B.M. of Douglas fir and incense cedar, 2,695,000 feet B.M. of white fir and other species, of which about 450,000 feet B.M. of ponderosa pine stands on approximately 220 acres of 3 approved contracts must afterward be made with allottees desiring to sell and on terms similar to the contract for the unallotted timber. Each bidder must state the price per thousand feet B.M. Scriber Decimal C Log Scale that will be paid for timber cut, and scaled prior to any removal of rates as specified in the contract. No bid will be considered for less than \$37.50 per thousand feet B.M. for ponderosa pine and sugar pine, \$5.65 per thousand feet B.M. for lodgepole pine, \$12.30 per thousand feet B.M. for Douglas fir and incense cedar, and \$5.65 per thousand feet B.M. for white fir and other species. A certified check for sixty thousand dollars, payable to the Treasurer of the United States, must accompany each sealed bid. Persons bidding for or on behalf of companies, corporations, or partnerships must at the time of bidding submit in writing satisfactory evidence of their authority to do so. The deposits will be returned to the unsuccessful bidders. The deposit of the successful bidder will be applied as part of the purchase price against timber cut on this unit only or retained as liquidated damages if the bidder shall not execute the contract and furnished satisfactory bond for one hundred thousand dollars (\$100,000) within sixty days from acceptance of his bid. If an oral bid is declared to be high at the close of the auction, the bidder must immediately confirm the bid by submitting it in writing on an Indian Service bid form. The right to waive technical defects and to reject any and all bids is reserved. The contract will specify that all designated timber shall be cut and removed from the unit prior to April 1, 1957. Advance payments will be required on each individual allotment contract as stipulated in the contract covering the entire unit. The first advance payment must be made within thirty days of approval of the individual allotment contract. Before bids are submitted, full information concerning the timber, the conditions of sale, and the submission of bids, should be obtained from the Superintendent, Klamath Indian Agency, Klamath Agency, Oregon; the Area Director, Indian Service, Building, Swan Island, Portland 18, Oregon; or the Commissioner of Indian Affairs, Washington 25, D.C. It Happened This Way in New Pine Creek

By IRVIN FARIS The strange case of Edward Howard adds up to puzzlement. He drove into town little over a week ago in an antiquated Chev sedan on a stormy night, pulling a reasonable nice trailer. On the quiet for two or three days, he apparently did the taverns of the town in companionship with an elderly hitchhiker whom he had picked up along the way up through California. For why the couple did not sleep in the trailer, is not known, unless it was a wee too chilly. However, they managed to take refuge from the bleak night at the Gus Doring rooming house after experiencing some difficulty arousing the proprietor. Then—they stayed several nights. Lodging for the two was paid for by Howard who seemed to have money. This fact was attested to by Ralph Howard and wife who came looking about his brother's demise, last Saturday, accompanied by county coroner and Lakeview undertaker, Everett Ocklerman who had gotten in touch with them on Wednesday. The relatives said Edward had had quite a little money on his person, they thought, when he left Torrance, California, about 10 days ago. The elderly companion whose name was not learned, had disappeared a couple of days before Howard's body was found in an outbuilding on the Doring premises, at about 1:30 last Wednesday afternoon. He had been dead about twenty minutes, it was believed. Earlier that morning Gus Doring had come over and told us he had a sick man over there. "He's out on a chair by the stove, talking to himself. I think something should be done." So we called the County Health Nurse and notified the sheriff's office. In the meantime the stranger had gotten up from his chair and wandered out in the back yard where his car was parked. Gus watched him stumble and fall a couple of times as he attempted to jack up his trailer, evidently to disengage it from his car. He may have contemplated driving himself to see a doctor. Then he disappeared into the outbuilding where he was later discovered by Charles Mattson, a roomer at Gus's. Upon Howard's person was found a deed to a forty acre piece of land up near Plush, Oregon, where the stranger was going when misfortune overtook him. The body was taken to New Mexico for interment. The relatives said they would be back after the car and trailer later. It is in storage at the Myer's garage building in Lakeview. An autopsy showed Howard died of pneumonia. A very lovely wedding shower was held at the Grange Hall Monday evening, February 1, in honor of Mr. and Mrs. Don Sanford who were recently married in Lakeview, where they now make their home. Seventy or more invited guests were present to enjoy, with the young couple, seeing the many useful gifts of well balanced variety that they received. A short program preceded the viewing of the gifts which consisted of a darkie clog dance by Beverly Vincent, accompanied by Mrs. Susan Vincent on the piano, and two short readings by the chairman of the shower committee, Mrs. Bona Faris. Other members of the committee who helped make the event a pleasant success were: Mrs. Mary Snider, Mrs. Sara Johnson, Mrs. Hilda Lenkeit, Mrs. Maude Butler and Mrs. Faris. Refreshments were served at the close of the gathering, which started at 8 o'clock and closed at around 11 p.m. Mrs. Lee Bernard filed in on the committee at the shower, taking the place of Mrs. Sara Johnson who had left that morning for Portland, with her husband who went for a check-up operation treatment and post-check-up at a Portland clinic. The Johnsons were expected back sometime Tuesday or Wednesday. Mearle Dolson, a former resident of NPC, dropped in last Wednesday to extend home greetings. He was to catch a plane the next day, Thursday, at Klamath Falls for El Paso, Texas, where he has been stationed for the past several months. His leave was for 13 days. On Sunday, January 30, he was to take a plane for New York. Thence, he was to leave for duty in Germany to serve in the army anti-aircraft division. We wished him the best of luck and hoped he would not have to do any fighting—just routine patrol duty and sight-seeing.
