Church Group Gives Protest

BOGOTA, Colombia (AP)—Columbia's Evangelical Confederation, protesting anew that this Catholic nation is persecuting Protestants, has charged that 15 persons attacked an Oregon missionary and his pregnant wife, beating and kicking them.

The confederation said the victims were the Rev. and Mrs. Warren O'Dell Nowowiejski. Assemblies of God workers from Salem, Ore. It reported Wednesday they were assaulted at Bogotazo, Boyaca Department; that Mrs. Nowowiejski was knocked to the ground and that their home was looted.

The interior ministry said the complaint was being investigated. The Protestant confederation complained also that seven Protestant primary schools, with 500 students enrolled, have been ordered closed in the Caribbean island of San Andres and Providencia.

An interior ministry official said the islands are Catholic mission territory, and non-Catholic schools are not permitted.

The Evangelical Confederation contended, however, the islands had been predominantly Protestant for generations and charged the government was "moving to implement its announced program of religious unification in the islands."

The confederation said three of the schools were operated by Baptists affiliated with the Southern Baptist Mission, who had started work in the islands a century ago, and four by Adventists who started their first institution in Providencia 40 years ago.

The Red Cross here said it has had no reply in the 10 days since it asked for data.

Rajkumar Amrit Kaur, chairman of the Indian Red Cross and the country's health minister, sent a letter to the Chinese Red Cross in Peking after receiving a plea for information about the trio from the Foreign Correspondents' Club in Tokyo.

Justice Dept. Studies Condon Testimony

WASHINGTON (AP)—The Justice Department has obtained the transcript of a congressional hearing into allegations of Communist association made against Rep. Robert L. Condon (D-Calif.) but has given no indication of any action it might take.

This was reported Thursday by Rep. W. Sterling Cole (R-N.Y.), chairman of the Senate-House Atomic Energy Committee, which heard Condon testify under oath that he was ever a Communist or a Communist sympathizer.

Condon was barred by the Atomic Energy Commission (AEC) from witnessing last May's atomic tests in Nevada on the basis of reports that he had associated with alleged Communists in the past. Condon asked and received a hearing under oath earlier this year before the atomic committee.
