DENVER, (AP)—Two Utah couples were killed Monday as their light plane crashed in an east Denver residential district. The craft narrowly missed homes, a grade school and a hospital.
The victims were Roland B. Smith, 50, and his wife, 38, of Clearfield, Utah; and William E. Robins, 30, and his wife, 28, of Ogden.
Their Beechcraft Bonanza crashed shortly after taking off from Stapleton Field. The party was en route to Wichita, Kan., and made a refueling stop here. A gust of wind was tentatively blamed for the crash.
