# Dairymen Hold KF Meeting

Local dairy products distributors were hosts at a Thursday luncheon at the Winema Hotel to more than 50 persons interested in the promotion of successful annual June Dairy Month.

Percy Murray, of Klamath Falls Creamery, presided, and introduced guests from out of town, including Tony Larsen of the Sunshine Dairy, Portland, state chairman for June Dairy Month; Oscar Hagg, dairy industry specialist from Oregon State College, and Grace Workman, manager of the Oregon Dairy Council, Portland.

Guest speaker was Glen Lay, executive secretary of the Oregon Dairy Products Commission, who outlined the full promotion program which has been prepared by the dairy council in cooperation with American Dairy Association, Chicago.

"It is a \$54 million industry," Lay stated. "Thirty per cent of our food needs can be purchased by 15 per cent of the food dollar by using dairy products. One out of every 15 persons are dependent on the dairy industry for his livelihood as a national average," he added.

"We have surpluses in the dairy industry. We want those surpluses in tummies and not in caves," he declared.

"Surveys show that 50 per cent of the people in the United States are on a diet, most of them to reduce. We must educate those persons that dairy products are not fattening and are necessary to the health and energy of the dieter."

This year's theme for June Dairy Month is "Dairy Foods for Taste, Health and Economy." This will be Oregon's 18th observance of national June Dairy Month.
