STOCKS

NEW YORK (AP) — After a favorable start, the stock market turned mixed Monday in the late afternoon. Changes in either direction were quite small and seldom went past a point.

The pace of trading was slow both during the early rise and the later fall. Business amounted to 1,600,000 shares, one of the slower days this year.

Bridges Case May Reopen

SAN FRANCISCO (AP) — The federal government moved Monday to reactivate a civil case aimed at depriving longshore leader Harry Bridges of his U. S. citizenship on grounds he allegedly concealed he was a Communist Party member.

Australian-born Bridges, 52, was convicted in a criminal action April 5, 1950, of perjury in his naturalization proceedings but on June 15, 1953, the U. S. Supreme Court reversed the verdict because the statute of limitations had expired.

Federal officials said there is no statute of limitations pertaining to the civil case.

Bridges' attorneys had filed a motion for dismissal of the civil case. That removed it from the court calendar.

Monday Lynn J. Gillard, chief assistant U. S. attorney, filed a memorandum in opposition. This put it back on the calendar.

Next Monday a date will be set for arguments on the Bridges' motion to dismiss.

Both the criminal and civil actions were filed simultaneously May 26, 1946, by the government.

"This move is for the purpose of reactivating the civil case which the government will bring to trial," Gillard said.

Mac Recall Move Fails

SAUK CITY, Wis. (AP) — The Joe Must Go Club announced Monday it failed to obtain enough statements on petitions to recall Sen. McCarthy (R-Wis.).

The club issued a statement signed by its officers declaring the drive to secure signatures, which ended at midnight Saturday, did not reach the 403,904 signatures required by law.

The club did not report on the number of signatures it did obtain.

"Although the 403,904 legally required signatures were not obtained, the members of the recall group are very heartened and pleased at the tremendous response they received from their efforts," the statement said.

Officers of the club, who last week indicated they felt the movement would not succeed, reiterated they would not give up their efforts to unseat McCarthy and would investigate and study the possibility of a future recall movement.

The statement was signed by LeRoy Gore, Sauk City weekly newspaper editor, executive secretary of the club and its founder and others.

Even if the number of signatures had been sufficient there was no certainty of a recall election.

Car Crashes Mar Quiet Weekend

Three car crashes marred an otherwise quiet weekend in this vicinity. The first and most serious occurred about 1 p.m. Sunday when a car operated by Robert L. Unger, 23, with his wife and 3-year-old son plumed off the Spring Creek grade about five miles north of the Chiloquin junction on Highway 97.

The trio were traveling south to the Naval Air Station at Moffatt Field, where Unger is stationed. According to Oregon State Police, the driver said he apparently went to sleep at the wheel.

Kaler's Ambulance Service brought the victims to the Klamath Valley Hospital where Unger was treated for lacerations and a possible chest injury. Mrs. Unger received minor cuts and bruises and the boy suffered minor bruises.

The car rolled over three times throwing the occupants clear, officers stated. The car was a total wreck.

Shortly after 3:40 p.m. Sunday while driving on the west side highway near Geary's Ranch, Winifred McLemore Fish, 5351 Broadway, Oakland, California, reported to state police the sun blinded her and she lost control of her car and drove over an embankment.

The woman was taken to the Klamath Valley Hospital by Kaler's where she was given medical attention and released.

A hit and run driver was said to be responsible for an accident that sent Siam Millon, 33, Fort Klamath, to the hospital for treatment of minor injuries.

According to Millon, he was driving toward Sprague River from Chiloquin, when a car occupied by two boys passed and sideswiped his car causing him to lose control. His car spun around and turned over, according to the report.

Millon was taken to Chiloquin by a passing motorist and then brought to the Klamath Valley Hospital by Kaler's ambulance. He is reported to have received a hip injury.

KF Firemen Attend Meet

Cliff Gay and Doyle Edwards, delegates from the local chapter, No. 890, International Association of Firefighters, have returned from the IAF annual convention held this year in Eugene.

One of the highlights of the convention, the delegates report, was an address by S. P. Stevens, vice president of the IAF in Portland, in which he urged the support, cooperation and understanding of public officials to build up the fire department to higher standards to render more efficient and service.

Stevens pointed out the increasing hazards in fire fighting and fire prevention in this atomic age, the more complicated and graver problems facing fire departments through increased use of synthetic processes in industry, the use of explosives and flammable materials in manufacturing plants, etc.

"I want to put this question up to the public officials of Oregon who have not given the proper consideration to these problems, and do not fulfill their duties and obligations to pay a living wage to fire fighters so they can give all their time to the fire services, because of substandard wages."

Stevens' talk blasted city officials who, he charged were adopting a saving plan that will result in fire losses and possibly the loss of lives.

Local delegates commented on the appropriateness of the topic in view of the recent refusal of wage increases for the local fire department.

California Politicians Facing Vote

TULELAKE — Aspirants for offices in Siskiyou and Modoc counties, completed some rugged campaign schedules Saturday to await the results of balloting in the California primary election, Tuesday, June 8.

Probably the most hotly contested seat for a Siskiyou county office will be that between incumbent A. B. "Al" Cottar, who is challenged by Fenton Mahrt, former chief of police of Dorris. This contest has blossomed into a heated race in the waning days of the campaign, with both contestants making quick last-minute rounds among the voters.

Under recent re-organization of Siskiyou county offices, authorized by the Siskiyou county board of supervisors, the office of coroner will be filled by the sheriff. Previously the offices of coroner and administrator were held by the same official.

This year also, the offices of auditor and recorder have been consolidated by the board and the district attorney will also function as administrator under the new regime.

Ernest T. Johnson, incumbent recorder, runs against Alton Stuart Taylor in the race for the auditor-recorder job. Warren Seward, recorder incumbent, is retiring.

District Attorney Floyd Merrill, incumbent, has filed for the combined district attorney-public administrator spot. He is unopposed for re-election.

Six other unopposed county offices in Siskiyou county are Supt. of Schools, W. E. Roberts; County Clerk, Waldo J. Smith; Tax Collector - Treasurer, B. G. Jack; Isaac; Assessor, Babe Taylor; Surveyor, Albert P. Parrott, and F. A. Dobson, constable of the Tulelake judicial district.

Roy E. Simpson, incumbent state superintendent of public instruction is faced by four opponents, David B. Everett, Peter A. Luppen, Harry C. Steinmetts and Edward L. Alberts.

In Modoc County Tom Walls, incumbent assessor, retiring, leaves the field open for H. T. Osborne, Newell, and three Alturas candidates, Marjorie K. Herkerson, Thomas E. Lavy and Harold O. Morgan.

The name of Samuel O. Phillips, making a bid prior to his death for assessor-tax collector, will be on the ballot.

Charles Lederer, narrowly defeated by incumbent Paul K. Baker, at the last election, is making another bid for the office of district attorney in Modoc county.

Millicent DuBois, deputy in the office of the Modoc county clerk, and Gilbert E. Wardell are on the ballot for county clerk. Ella Sloss, incumbent, is not a candidate.

Merville E. Archer, incumbent, is being challenged for the office of auditor-recorder by Robert S. Nelson.

Wards 2 and 3 will vote at the city hall, Ward 3 at the Legion Hall. Voters in the Winema precinct will vote at the Winema school.
