

Former Attorney General Criticized By House Group

WASHINGTON (AP)—A House Judiciary subcommittee, in a disputed report, criticized Justice Tom C. Clark today for declining to testify after he joined the Supreme Court but said it had turned up no proof of wrongdoing by Clark while he was attorney general.

The document drew immediate fire from Rep. Byron G. Rogers, committee member, who said Chair (D-Colo.), one of the five subcommittee members (R-NY) pulled a "sneak play" by his "unwarranted political release . . . of his proposed libelous report."

Rogers denounced Clark, an appointee of former President Truman, and said most of the report had not been approved in subcommittee or even considered by the committee's inquiry last year into parent judiciary group.

"The report, dealing with the subcommittee's inquiry last year into operations of the Justice Department, said the investigators were 'troubled' because some controversial actions were traced back to Clark. Clark was attorney general in 1945-49 before going to the Supreme Court.

Keating said in an accompanying statement that Clark's failure to testify was "unfortunate" because "we were deprived of the benefit of any light which might have been shed by a former member of President Truman's Cabinet."

Clark could not immediately be reached for comment. But Rogers called Keating's statement "completely baseless" and accused the New York Republican of violating his own fair play code in making the report public.

The 133-page printed report contained no signatures of subcommittee members in its major sections. At various points "Minority views" were contained under Rogers' name. Separate views were also entered by two congressmen who were members of the full committee but not the subgroup.

There was no explanation why the report, transmitted to the parent committee 11 months ago, has not yet been acted on there.

The report said the subcommittee "found no conclusive evidence of wrongdoing by Justice Clark at any point during his service in the (Justice) department." Then it said:

"It was troubled, however, by repeated suggestions in the testimony of his associates and subordinates that some of the actions for which they have been criticized were traceable, ultimately, to him.

"His testimony alone could have removed the last doubt that the responsibilities the subcommittee has placed on various department officials came to rest, in every case, on the right shoulders."

The printed report summarized eight different phases of the subcommittee's investigation including an invitation to Clark to appear before it and testify. It reproduced a letter from Keating sending the eight reports on to the full Judiciary Committee last Aug. 6. Another letter by Rep. Chauncey W. Reed (R-Ill.), chairman of the full

committee, said that with the exception of one of the eight portions, the subcommittee report "has not received the consideration of the committee . . . and does not necessarily reflect the judgment or conclusions of this committee."

Rogers, in a separate statement, cited these circumstances and noted that one of the rules which Keating proposed and the subcommittee adopted—and which is reprinted in the document—reads: "No report shall be made or released to the public without the approval of a majority of the full Committee on the Judiciary."

Rogers also said he had evidence that there had been "flagrant instances of suppression of vital documents and evidence during the course of this investigation, either by Mr. Keating or by members of his staff," and that he would ask the full committee to look into the matter.

Keating, in a statement accompanying the report, termed "unfortunate" the Clark episode, and he added:

"There is little hope that the situation which remains untouched — the Supreme Court Justice who refused to throw any light on his years of service in the department will ever be revived or effectively pursued."

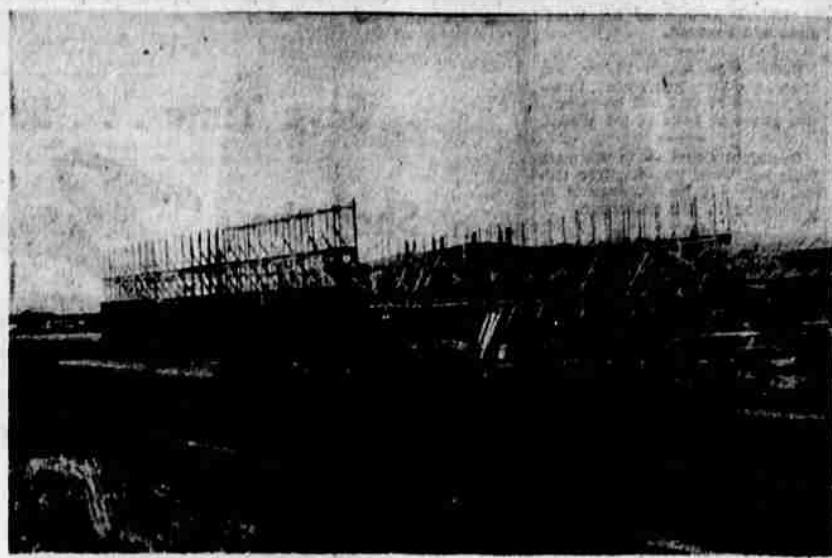
In a minority dissent printed with the report, Rogers commented: "Just what evidence Justice Clark was expected to give to this committee it did not already possess is not made clear."

There were many references to Clark in the group's hearings, and Keating wrote him June 15, 1953, citing some of them and inviting him to testify. The Justice replied two days later that "the courts must be kept free from public controversy" and that therefore he would not follow a "personal inclination" to testify. He submitted a memo commenting on some of the cases investigated.

Among the recommendations which the subcommittee made:

1. A revision of laws dealing with conflicts of interest, between service to the government and service to private interests by present or former government employees.
2. A re-examination of bribery laws with relation to gifts between public officials and citizens affected by the authority of such officials.
3. Recognition of the quasi-judicial nature of certain administrative officers and the need for a high standard of ethics because of this situation.
4. Closer supervision of the offices and activities of the U.S. attorneys.
5. Closer scrutiny of the professional qualifications of presidential appointees.
6. Greater uniformity in the handling of federal grand juries.

Two Accidents Mar Holiday

Two highway accidents north of here marred an otherwise quiet Fourth of July holiday, according to Oregon State Police.

The first of the two mishaps, which sent Mr. and Mrs. J. M. Faubian, Arbuckle, California, to the Klamath Valley Hospital for treatment, occurred about noon Sunday at the Junction of Highway 62 and 97, north of Modoc Point. The accident happened when the Faubian vehicle plowed into the rear of another operated by Kindell Weir, 2246 North 99th, Eugene.

The Weir car turned over at the side of the road but neither the driver, his wife nor daughter, who were passengers in the car, were injured.

The Faubian couple was taken to the hospital by Kaler's Ambulance Service where Mrs. Faubian was found to have a broken arm and possible internal injuries and Faubian received a badly cut head.

Three others were hospitalized late Sunday evening when a pickup driven by Worden Gale Eggman, averted to miss a tractor operated by Gene Gratton, about four miles north of Modoc Point.

The pickup rolled over throwing the driver and four passengers out. Mary Knight, her 10-year-old sister Judith Ann and Eggman were taken to the Klamath Valley Hospital for treatment. Gerald Captain and Annette Haskins, also passengers in the pickup were uninjured. All six persons involved are residents of Chiloquin.

Of the five persons injured Mrs. Faubian was the only one remaining in the hospital today. The others had been given medical treatment and released. Mrs. Faubian was improving satisfactorily, hospital authorities stated.

Lorella Man Takes Own Life

Charles Reeves, 78 Lorella, took his own life by shooting himself in the head with a .22 caliber rifle shortly before 5 p.m. Monday, according to Oregon State Police.

The aged man had been in poor health for several years and recently had become despondent, his son-in-law Orville Schroeder told authorities. The suicide occurred at the Schroeder ranch about four miles south of the Lorella store.

The body removed by Deputy Coroner Ward to Ward's Klamath Funeral Home. Date of the funeral will be announced later.

HOLLYWOOD (AP)—Mae West has some advice for Marilyn Monroe: you'd better win over the ladies, baby.

Miss West, still the epitome of sex, is a logical party to hand out advice. She made millions by muttering spicy comments. She can still command a top salary, as she will when she opens at Las Vegas' Sahara July 27.

I won an audience with the

fabulous star in her sixth-floor apartment near the heart of Hollywood. The living room was unbelievably garish. It was all done in white, with Louis XIV furniture trimmed in gold. On one wall was a nude painting of Miss West, for which she says she has refused a \$100,000. Atop the piano was her nude likeness in white marble. Beside the statue were tintypes of her parents.

Miss West's entrance was in character—she sauntered into the room in a flowing negligee. She looked impressive. The record books indicate she's around 60, but she seems 20 years younger. Her figure is still plump and curvaceous, her skin smooth and her chin singular.

I asked her how she felt about Marilyn Monroe.

"I haven't seen her on the screen," Miss West said in her soft, nasal voice. "But folks tell me she is using a lot of the things I do. The walk, for instance. They tell me she walks the same way I do. And the humorous things she says. I don't know whether she has said them herself or not. At any rate, the press boys have done a good job on her."

"But if she's as great as they say she is, why isn't she saving the studio, the way I did with Paramount? I paid off the mortgage on the place."

Miss West reflected on her own rise to fame and said she "broke records everywhere" because she

didn't alienate the female audience.

"You'll notice in my pictures I never went after a married man or took a man from another woman," she said. "I always treated other women with respect. That was all part of my plan to keep the women in the audience happy."

Ceremony Held By U.S. Jews

NEW YORK (AP)—The American Jewish Tercentenary, commemorating the 300th anniversary of Jewish settlement in this country, was proclaimed formally yesterday.

Ceremonies were held on the steps of the congregation Shearith Israel, founded in 1730 by descendants of a small group of Spanish refugee Jews who landed in 1654 in New Amsterdam, the old Dutch name for New York.

The proclamation fixed the period of the tercentenary between Sept. 12, 1654, and May 29, 1955.

Three rabbis read the proclamation, which was signed by leaders of Orthodox, Conservative and Reform Jewish rabbinic and synagogue bodies.

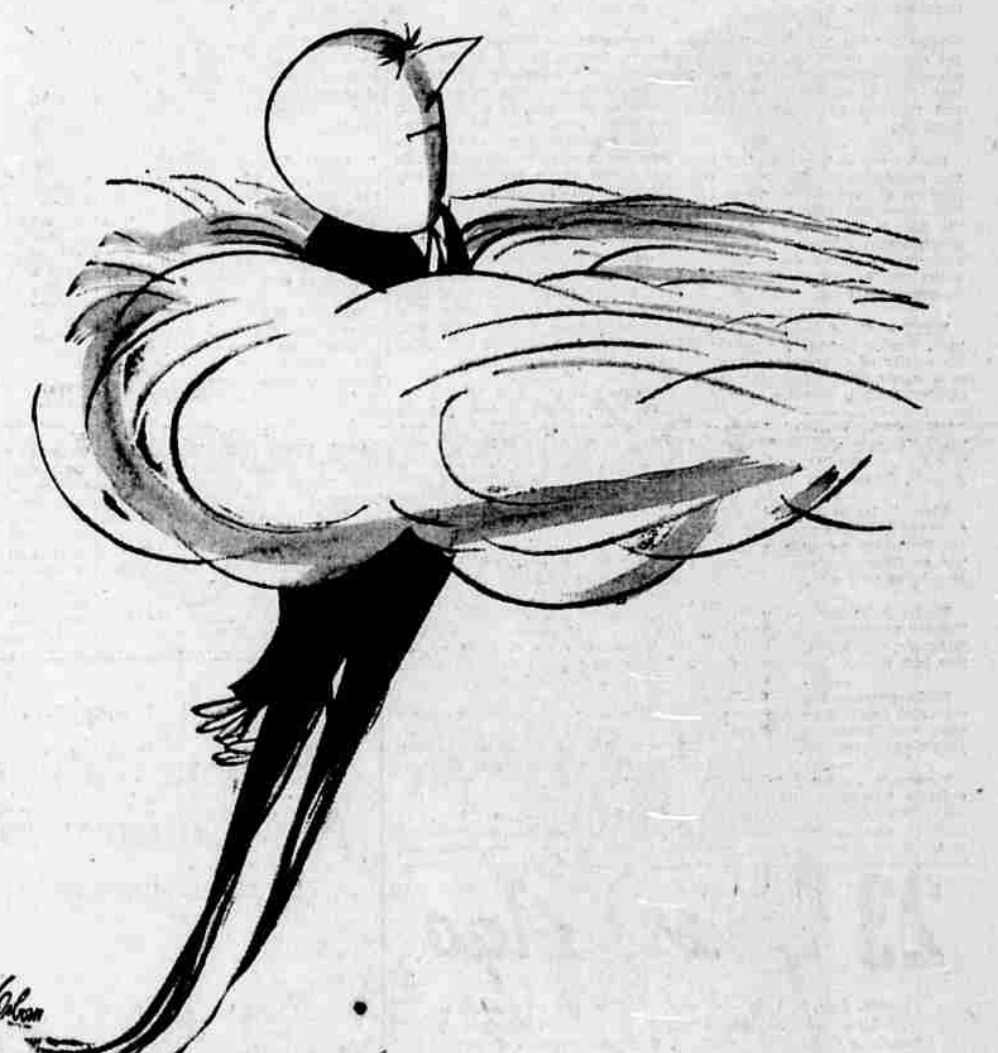
