CHICAGO (AP)—Strength in soybeans and some wild last minute high bids in wheat, which ended lower, featured dealings in grains on the board of trade Friday.

July soybeans responded to short covering while the new crop months reflected continued lack of import moisture in the Midwest. Beans were ahead throughout the session, closing around their day's best levels.

Wheat eased at the start and then responded to a strong rally in the last hour. Gains were substituted for losses. But in the closing minutes the bread grains retreated sharply, ending a couple of cents below the day's high.

Wheat closed 1 1/2, lower to 1/2 higher, July 2.08 1/2-2.09, corn unchanged to 1/2 lower, July 1.58 3/4-1.59, oats 1/2 lower to 3/4 higher, July 1.07 3/4-1.08, soybeans 4 3/4-7 1/2, higher, July 3.94 1/2-3.97, and yard 5 cents lower to 5 cents a hundred pounds higher, July 16.40.

Famed Portland Architect Dies

PORTLAND (AP)—Funeral services were held Friday for Arnold Ralph Southwell, 51, who was one of the designers of the Empire State Building in New York City.

Southwell, a Tacoma native, was a widely known architect who also helped design the Juilliard School of Music Building in New York City.

He received the American Institute of Architects' medal for design in 1925, the same year he was graduated from the University of Oregon.

He died at his home in nearby Oswego Wednesday.

Surviving are the widow, Alice; a daughter and a son, all of Oswego; two brothers, Ambrose of Seattle and Schuyler of Oswego; and his mother, Mrs. A. N. Southwell, Tacoma.

Senator Potter Determined To Force McCarthy Shakeup

WASHINGTON (AP)—Sen. Potter (R-Mich) said today he will "stand pat" in efforts to force a shakeup of the Senate Investigations subcommittee's staff after Chairman McCarthy (R-Wis) blocked them at least temporarily yesterday.

Potter and three Democratic subcommittee members, a majority of the seven-man subcommittee, are seeking the dismissal of some McCarthy-appointed aides on the group's staff.

In a closed-door meeting yesterday at which heated words were said to have been exchanged, McCarthy:

1. Announced he would launch public hearings in Boston Saturday to explore his charges of Communist infiltration of defense plants, without waiting for any showdown on the staff.

2. Threw out the proxy vote of the absent Sen. McClellan (D-Ark.) Sen. Symington (D-Mo) had tried to cast it in favor of Potter's motion to fire on July 31 any staff aide not confirmed in his job by a majority subcommittee vote before that date.

3. Recused the meeting until Tuesday noon after Sen. Dirksen (R-Ill) had proposed a less drastic motion for judging who, if anyone, should be fired.

Tuesday also is the day when Sen. Flanders (R-Vt) has announced he will move to force a test vote in the Senate on his demands that McCarthy be stripped of committee chairmanships or be censured.

The 12-member Republican Senate Policy Committee announced yesterday it was lined up unanimously behind Sen. Knowland of California, the Senate GOP floor leader, in his announced plans to try to kill the Flanders motion.

Flanders says he wants the Wisconsin senator removed from committee chairmanships to end what he terms McCarthy's "destructive" force in the Republican party. The policy committee gave no reason for opposing his move.

DISPUTE—Symington and Sen. Jackson (D-Wash) both disputed McCarthy's decision refusing to count the absentee vote for McClellan, which they said would have assured a 4-3 margin for Potter's motion on the subcommittee staff. But they said they could not appeal the decision without encountering a 3-3 tie vote, which would have allowed McCarthy's ruling to stand.

McCarthy ruled that McClellan's proxy, telegraphed from Arkansas where he is campaigning for re-nomination, was a "blanket" document drafted to meet any situation. He contended subcommittee rules require that such votes be drafted to cover specific issues.

Just what the procedure will be when the subcommittee meets again Tuesday McCarthy declined to say. But Potter told newsmen: "I've made my motion and I'll stand pat on it."

He said he would oppose the Dirksen motion if there is an effort to bring it to a vote ahead of his own.

Dirksen's motion would instruct McCarthy to call a meeting "on or before July 22" at which the employe roll would be called and each person named become subject to a motion to fire him. He would also provide for review of a dismissal order if a fired staffer requested it.

SPECULATION—Potter never has named publicly the staff people he wants fired. There has been speculation he is gunning chiefly for Roy M.

Man Demands Court Hearing

Henry John Zehe, 52-year-old laborer, accused of molesting a child in a downtown theater, demanded a preliminary hearing when he appeared before District Judge D. E. Van Vorst Friday.

The court set the hearing for next Tuesday. Zehe, a German immigrant, is charged with contributing to the delinquency of a minor.

According to District Attorney Frank Alderson, Zehe was chased from the theater by Arthur Bryant of Bay and Arlo streets overtook the alleged child molester on Main street and held him until city police arrived. In lieu of \$2,500 bond, Zehe was ordered held in the county jail.
