Youth Held For Arson

BURBANK, Calif. (AP)—A 13-year-old boy, recently released from Juvenile Hall after a year's detention for arson, is back in custody after setting another fire. Police said he caused nearly \$600,000 damage in 15 fires last year. They included a \$350,000 lumber yard blaze and a \$300,000 warehouse fire. A condition of his release was that he have 24-hour supervision at home. Lt. Stanley Paggeot, head of the police juvenile bureau, said the latest fire was set during an absence of less than 10 minutes. He said the boy soaked papers in oil and ignited them in a guinea pig cage near a pet shop. A passer-by extinguished the flames before the animals were injured. The boy said his pet, a ring-necked dove, died while being cared for in the shop while he was at Juvenile Hall.

Big Sum Paid For Horse

LEXINGTON, Ky. (AP)—A fabulous \$80,000 bid for a chestnut son of Nasrullah, a record American price for a thoroughbred yearling, echoed from Kentucky's Bluegrass horse country to Texas today.

F. J. Adams of Fort Worth, retired oil executive, bought the colt for the Adams Syndicate from the consignment of Clifford Mooers' Walnut Springs Farm. Adams, a newcomer to the breeders' sales, summer auctions, is retired vice president of the Gulf Oil Corp. and Gulf Refining Co., and a director of the Southwest Exposition and Fat Stock Show in Fort Worth.

The contending bidder for the Nasrullah-Larkie B. colt was A. E. Reuben of Toledo, Ohio, master of Hasty House Farm. Reuben gave the \$23,100 for a yearling from the Mooers' consignment in the 1952 summer sale and the colt, Hasty Road, became the leading money winner among juveniles in 1953 and captured the Preakness this spring.

The old record for a yearling was the \$75,000, which Eastland Farm Syndicate gave in 1928 for New Bloom.

Nasrullah was second among the leading sires in England last year. The imported stallion is the sire of Noor, who four times raced Citation, the turf's only millionaire, into defeat.

Pilot Lands in Public Park

KALAMAZOO, Mich. (AP)—George Gruchacz, 30, of Detroit, landed his single-engine private plane on the Dickinson Ball Field in Kalamazoo last night.

Gruchacz surprised 40 spectators watching an amateur baseball under the lights. He was unhurt and the plane undamaged. He landed several hundred yards from the diamond in the public park.

Gruchacz explained to police he had lost his way on his flight from the Dickinson Ball Field, near St. Clemens, to Saugatuck on Lake Michigan.

Dinner Planned For Roy Cohn

NEW YORK (AP)—A testimonial dinner will be given tonight for Roy M. Cohn, and the sponsors there is room for only a fraction of those who want to attend. Cohn, a key figure in the recent Army-McCarthy hearings, resigned as chief counsel for the Senate investigations subcommittee after the hearings ended. Sen. Joseph R. McCarthy (R-Wis.), chairman of the subcommittee, will be speaker.

Tonight's dinner had been planned before Cohn's resignation. The Joint Committee Against Communism in New York, which organized the Cohn testimonial, said it had to turn down 5,500 applications for tickets.

About 2,000 are expected to attend the dinner in the Hotel Astor at \$7 a plate.
