Labor Strikes Increasing

WASHINGTON (AP) — The tempo of labor strikes, after dropping to a postwar low earlier this year, is increasing with the nation facing immediate walkout threats in the aluminum and airline industries.

A strike of 1,200 pilots of American Airlines has been set for midnight Friday by the AFL Airline Pilots Assn. The dispute concerns the union's protests against scheduling pilots for more than eight hours continuous flight on nonstop, transcontinental service.

The National Mediation Board tried for two weeks to settle the American Airline controversy but finally gave up and the union set the strike date. President Eisenhower still could avert the walkout by naming a special emergency board to study the dispute.

More than 20,000 CIO Steelworkers Union members in more than a dozen plants and mines of the Aluminum Company of America and Reynolds Metals Co. have threatened a walkout at midnight Saturday. This could halt about half the country's aluminum production.

Federal mediators were still working to stave off the aluminum walkout but said the companies planned to start gradual closing down of mills Friday night unless the labor dispute is settled.

The aluminum firms have offered a five-cent hourly pay boost to workers now earning between \$1.54 1/2 and \$2.25 an hour. The union wants a minimum eight-cent pay boost plus other concessions.

Parliament Discussion Casual One

LONDON (AP) — Immaculately groomed Anthony Eden put his feet up on the speaker's desk in the crowded House of Commons. On the other side of the desk, former Prime Minister Clement Attlee, leader of her majesty's loyal opposition, did the same.

A discussion of grave importance dropped on one day this week. "The talk was about the Suez Canal and Egypt. At stake was another chip from the British empire. The empire was shrinking. But even that occasion failed to make the mother of parliaments as formal as, say, a ladies aid meeting in the United States.

In the wood-paneled chamber 16 microphones rolled out the words of the speakers. When Eden first entered he got something like a round of cheers—and a scattering of less complimentary noises. It was just a little like the sounds you get at Ebbetts Field when a new relief pitcher comes on.

Then in came Winston Churchill. Conservatives and Laborites both set up a din. Most of it was warm welcome for the old man in his 80th year.

Churchill, poker faced, ignored the demonstration. He sat down like he owned Parliament. Dozens of questions were put to Foreign Secretary Eden about "the latest retreat from empire," as a disgruntled member phrased it.

But hardly at any time was the undivided attention of everyone directed at Eden, or anyone else who had the floor. Legislators chattered among themselves, stomped their feet, shouted agreement or disagreement, walked in and out of the House, made frantic gestures to catch the eye of the speaker of the House, so they could get a word or two in.

Eden, seated, was at ease. He laughed out loud several times, slapped his knee in enjoyment, sometimes whispered in Churchill's ear.

The prime minister never cracked a smile, spoke aloud hardly a word.

Through it all one member—on Labor's side—achieved the ultimate in relaxation. He stayed sound asleep.

This year industry will put out millions of Do-It-Yourself kits, provide thousands of Build-It-Yourself projects from tractors to prefabricated doghouses.

This year alone, hardware stores will sell 8,000,000 paint rollers, a gadget which has revolutionized the paint industry. Latex-base paints which spread easily, dry in an hour and are practically odorless, have been developed. So have new tiles of rubber, asphalt, cork and plastic, tough plastic laminates of countertops, pre-trimmed and packaged wallpaper and dozens of other easy-to-install products.

\$10 BILLION BY 1960? In the fast-growing market, the fastest-growing business of all is in the basic machines for the Do-It-Yourself workshop. Before the war, the power tool industry rarely topped \$25 million in sales; now it is a \$200 million business with a 25% increase predicted for 1954.

Has the Do-It-Yourself boom reached its peak? No one thinks so—at least of all the Do-It-Yourselfers. As their skills increase, they see themselves tackling bigger and bigger projects. The man who has put together an 8-ft. pram begins to leaf through plans for an 18-ft. cruiser. The woman who has restuffed and recovered an old chair begins to wonder if she could not make a set of furniture for the dining room. Sales to the "shoulder trade" are climbing so fast that by 1960 the estimates are that they will be well over \$10 billion!
