An audience of more than 600 persons in Mills School Auditorium gave rapt attention to the versatile performance last night of David Rubinoff, whose program repertoire ranged from the romance of Clair de Lune, through his moving Warsaw Concerto to his concluding square dance melodies.

His encore number was Brahms' Lullaby.

Rubinoff, a native of Poland, was presented on his second appearance here in 10 years, under auspices of the Klamath Falls Lions Club.

Forty per cent of the ticket sales is retained by the sponsor organization for local charitable uses. Part of this fund goes to the YMCA, part to the sight project sponsored by the Lions Club.

Rubinoff gave short concerts Monday, September 20, in all city schools and played to more than 1,000 children in Mills School yesterday afternoon.

His accompanist was Homer Phillips, who has been with Rubinoff for 25 years. Concert audiences have heard him on radio, and MGM, Samuel Goldwyn and Paramount productions as the artist for background music.

The senator will be escorted by motor caravan to Jen-Ed's restaurant where he will be guest of honor at a buxaroo breakfast at which party leaders will play host.

Senator Kefauver is slated to address a rally in Mills School Auditorium at 1 p. m. Sunday. The rally will be followed by a conference with party leaders. Then Senator Kefauver will go by automobile to Medford.

Henry Hansen, chairman of the Klamath County Democratic Club, said Saturday Kefauver is counted on to swing the Democratic campaign into high gear in the Klamath Basin.

It appeared, though, he would try to show that Sack was at the apartment house at the time his wife Goldie, former Great Falls, Mont., school teacher, met her death.

Her body was found in a thick coat of town not long after Sack had gone to police and reported her missing.

Publisher Speaks To AA

Frank Jenkins, publisher of the Herald and News, lashed out Friday night at what he termed "do-gooder groups that maintain hirelings to do the good."

Jenkins spoke to an overflow audience at the Alcoholics Anonymous Center in Maple Park. The meeting was attended by AA members from all parts of the Klamath Basin.

"One of the things I like about Alcoholics Anonymous," the publisher said, "is that its members do not rely on paid social workers to carry on their program. AA members go about their work quietly and effectively."

"It's hard to find any other organization in the 'do-good' category today that doesn't maintain a corps of professional welfare workers. The big shits organize these groups but are too lazy to do any of the work."

Jenkins said he sincerely hopes that Alcoholics Anonymous will never resort to retaining professional welfare workers to achieve its purposes.

"I have the highest regard for AA and what it has accomplished in the rehabilitation of compulsive drinkers," he continued. "AA is rendering a great service to this community."

Dick G., chairman of the meeting, told the audience there should be no stigma attached to membership in Alcoholics Anonymous.

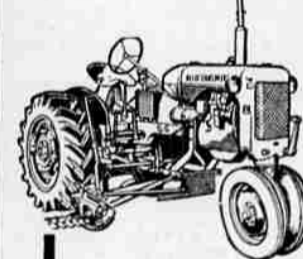
