

### Senate Backer Of McCarthy Questions Censure Ruling

WASHINGTON (AP)—Signs of a gathering storm over the proposed censure of Sen. McCarthy (R-Wis.) became clearer today as chairman Jenner (R-Ind.) of the Senate Rules Committee disclosed he intends to call Sen. Watkins (R-Utah) for questioning.

Among other things, Jenner said in an interview, he wants to find out why Watkins "conducted a one man hearing" as chairman of the special committee of three Republicans and three Democrats who unanimously recommended censure of McCarthy for certain aspects of his conduct.

This was a reference to a closed hearing at which Watkins questioned the Senate parliamentarian, Charles L. Watkins, about the validity of a Senate Elections subcommittee which issued a report critical of McCarthy on Jan. 2, 1953.

One of the counts on which the special committee recommended McCarthy be censured was that he was "contemptuous, contumacious and denunciatory" toward the Elections subcommittee in its 1951-1952 investigation of his financial affairs.

In one of his main lines of defense against the censure charges, McCarthy challenged the legal status of the Elections subcommittee. It was agreed to put the question up to the Senate parliamentarian.

Since parliamentarian Watkins—no relative of Sen. Watkins—had been ill, the committee and McCarthy's lawyer, Edward Bennett Williams, agreed to submit a set of questions. However, the parliamentarian later was questioned in Sen. Watkins' office.

Williams subsequently protested that the questions asked by Sen. Watkins went beyond the scope of those agreed on in advance. Williams asked to cross-examine the parliamentarian and his request was granted.

Jenner has been conducting hearings on proposed "codes of fair play" for Senate investigating committees. He said he wants to question Sen. Watkins as part of that study.

In his report recommending that McCarthy be censured, the special committee urged four changes in Senate rules. The group suggested

they take effect next January with the start of the new Congress.  
Under one of the proposed rules changes, no witness would be required to testify before fewer than two members of a committee unless the committee, by majority vote, had authorized a one man hearing.

Other recommended changes would bar the questioning of witnesses except by committee members or authorized staff personnel, and would forbid the disclosure of testimony taken in closed sessions except by majority vote of the committee involved.

Jenner said the Senate knew his committee was making a "diligent" study of rules changes to govern congressional investigations and that he didn't think the Senate would act on the proposals of the special committee. He said the rules committee would submit its report before the next Congress meets.

In addition to the count involving alleged contempt of the Election subcommittee itself, the special committee recommended that McCarthy be publicly and officially rebuked for allegedly denouncing members of the subcommittee in language "unworthy" of a senator and for allegedly "inexcusable" and "reprehensible" abuse of Brig. Gen. Ralph W. Zwickler at a hearing in New York last winter.

The Senate is to reconvene Nov. 8—the week after the congressional elections—to take up the censure charge.

McCarthy's friends in the Senate have indicated they intend to put up a determined fight, Jenner predicted that "many words will be spoken."

McCarthy, who has been in seclusion since the committee report was issued Monday, is scheduled to discuss it in an NBC television show ("Meet The Press") on Sunday.

### Federal Judge To Preside Over Segregation Hearing

CINCINNATI (AP)—A federal judge today pioneers the question of segregation in northern schools when he listens to arguments of Negroes and whites from the little southwestern Ohio city of Hillsboro. District Court Judge John H. Druffel is to hear evidence and arguments on a petition asking him to stop the Hillsboro board of education "from enforcing a policy of segregation."

It is the first case of its kind in the north since the U.S. Supreme Court ruled school segregation unconstitutional. The National Assn. for the Advancement of Colored People says it wants to make this a test case for northern schools.

Ever since the Supreme Court ordered integration of white and Negro classes, pro-segregation forces have asked this question: "How can they make us do it?" Druffel's decision involving the livestock producing city of 5,100 in the Ohio lowlands could provide a hint to the answer.

First, however, the NAACP would have to prove segregation actually exists in Hillsboro. The school board there claims it doesn't. These are some of the facts Druffel will have to consider: Nearly four-fifths of the 5,000 population is white; 67 of the 900 grade school children are Negro.

Both white and colored attend Hillsboro high school. At the beginning of this term Negro youngsters enrolled at the previously all-white Webster and Washington elementary schools as well as the previously all-Negro Lincoln school.

The city quickly rezoned the school districts, saying the Webster and Washington schools were becoming overcrowded. School officials say the rezoning was along residential lines. Negro leaders say it was along racial lines.

Its effect was to permit about three Negro children to attend Webster and Washington schools to channel the rest to Lincoln school.

School superintendent Paul Upp says the board planned, even before the Supreme Court ruling, to integrate all the children when two new buildings are completed in a year or so.

The injunction suit, filed by attorneys Russell L. Carter and James McGee of Dayton, Ohio, and Thurgood Marshall of New York, special counsel to the National NAACP office, claim the zoning action was intended as segregation and was contrary to the supreme court order.

### Candidates Give Speeches

Sen. Guy Cordon, campaigning for reelection, said Tuesday he had worked to settle jurisdiction of Oregon and California land grant properties, and "I am proud of this work."

He added, "I probably know more about O & C matters than any other man alive."

Cordon's principal talk of the day was at a Republican rally at Tillamook.

Richard L. Neuberger, the Democratic nominee, said in a talk at Ontario that Cordon and Interior Secretary McKay had brought about the "wrecking" of the staff at the Bonneville Power Administration. He said his election would signify to Congress that the voters in Oregon want Bonneville "returned to its previous effectiveness as a great agency for regional development."

He also said he would not use the "personal smear and character assassination tactics which have become routine for the Cordon organization and the hired professional lobbyists who serve on Cordon's staff."

Cordon described his political philosophy as a "feeling of independence and willingness to do things for ourselves."

"You're entitled to know how I feel," he said, adding that Neuberger "has not stated his philosophy."

SANTA MONICA, Calif. (AP)—Actor Scotty Beckett, 24, faces a hearing today on a felony knife possession charge.

The onetime "Our Gang" comedy player surrendered yesterday on a warrant issued last March 29. He said he had spent the intervening time in jail in Mexico on a bad check charge.

Beckett originally was charged here with robbery and possession of a dagger last Feb. 25 when the manager of a Westwood hotel reported theft of \$137. The robbery charge was dismissed yesterday.

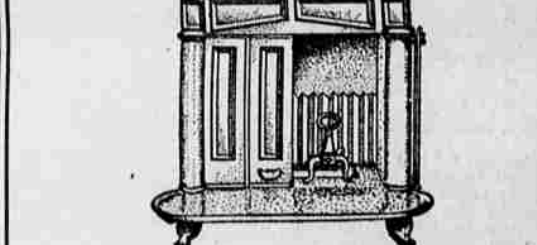
