

## Penn State Victory Takes East Off Hook

NEW YORK (NEA) — What with the rout of Pennsylvania by Duke and Army's snacking at the hands of South Carolina, Penn State's stunning victory over Illinois took eastern football off the hook.

When the Nitany Lions finished their 6-3 season last fall, it was pointed out that Rip Engle had lived off the passing of Tony Rados for two campaigns, and had no one to replace him.

But State College had a whole lot of a line and Coach Engle built a running game, with just enough passing to make it go.

Illinois lost its tackle, a guard and the center.

The Penn State tackles, Rosey Grier, Danny DeFazio, Otto Kneidinger and Gene Danz played top rung.

The passing of Don Bailey, who took over for Rados, might not have been too sharp, but he emerged a better than average

runner rolling up 80 yards, including a 50-yard sprint that set up the winning touchdown. He threw a 24-yard scoring pass.

The Penn State forwards made Halfback Lenny Moore look like an All-American. Moore more than held his own with J. C. Caroline. He picked up 124 yards in 17 carries for an average of 7.3. Caroline juggled the leather 18 times for 115 and an average of 6.4.

Penn State once more showed where football games are won — up front, mister.

Milton Campbell, perhaps the world's greatest all-around athlete, made his intercollegiate football bow with Indiana at Ohio State.

Campbell, the Olympic decathlon champion, went 46 minutes. The big New Jersey boy carried 13 times for a gross of 60 and a net of 48 yards. He caught one pass for short yardage, did some good blocking and was considerably more than adequate defensively.

The consensus was that while Campbell's debut was hardly spectacular he turned in an excellent solid workmanlike job.

"We were never able to spring Campbell into the open primarily because Ohio State concentrated its defense on him," explains Bernie Crimmins. "Every time we used him as a flanker there were two defensive men out there with him."

"Campbell did all right and I've got a hunch he's going to do still better."

If the Fighting Hoosiers are going anywhere in particular, Milton Campbell will have to step it up — and then some.

The colleges, which have gotten themselves into the television business, seem to have finally learned the trade to perfection.

In the Michigan State game, for example, the key play was a 52-yard punt return by Iowa's Eldean Matheson.

But the millions of television viewers saw only the last 15 yards or so of this most exciting run and Matheson being tackled on the Spartans' 3-yard line.

One of the several bucksters helping to pay for the telecast was busy selling a washing machine when the play started. Or it might have been a food freezer, a cigar, a shaving cream or something else. So many products have gotten in on the big Saturday afternoon act.

That puts the colleges right up there in the TV dodge.

Anybody who's customers to death with semi-literate commercials and you are a howling success in that field, it seems.

## Baker Whips Wallace

CLEVELAND (AP) — Bob Baker, a somewhat shopworn heavyweight hope with nine lives, is back in the scramble after whipping Coley Wallace, the motion picture version of Joe Louis.

Baker, now 28, has been threatening to become a top flight contender for years. Every time he gets close, something happens — bad hands or a knockout.

The Pittsburgh giant, still carrying extra weight at 213 pounds, floored Wallace, a New York puncher, for nine in the fourth round last night at the Cleveland Armory but he couldn't finish him. He gave him a good going over in the ninth and tenth, however.

Wallace disappointed his handlers by losing to Baker, the man who beat him for the Golden Gloves title in 1948 after Coley had whipped Marciano in an elimination amateur match.

There was no doubt about the decision among the 2,257 fans who paid \$7.20 to watch the bout. Referee Tony La Branche had it 96-90, Judge Charley Bill 95-87 and Judge Herb Williams 94-91, all for Wallace on the "must 10" point system. The winner gets 10 points and the loser nine or less. The AP card was 96-89 for Baker.

The Baltimore Orioles set a club record for homers in one inning when Cal Abrams, Bobby Young and Vern Stephens connected in the eighth inning of a game against Cleveland.

It should resolve in a battle of Los Angeles passing against San Francisco's running and passing game. Norman Van Brocklin, with Tom Fears and Elroy Hirsch as prime targets, will carry the aerial burden for the Rams, while Y. A. Tittle, a versatile quarterback who can run, pass and kick, directs for the rugged pros from Northern California. Joe (Jet) Perry and Hugh McElhenny give the Forty-niners a double backed running game. Deacon Dan Towler is the Rams' ground threat.

Both Los Angeles and San Francisco warmed up for their key battle with easy victories in last week's opening rounds of games. The Rams trounced Baltimore 46-0 and the Forty-niners walloped Washington 41-7. The two clubs met in an exhibition game with San Francisco winning 28-27.

There is little to choose between the two western title contenders.

Both carded one-under-par 71 in the opening round Friday to take a stroke lead over two other players who led off with 72s, Portlanders Lou Stafford and Kermit Smith. Two localites, Dr. E. G. Balmrose and Ralph Dichter, had 73s.

The defending champion, Eugene Harrington of Medford, carded a 75.

The field takes another 18 holes in the medal play affair Saturday and winds up with a 36-hole final Sunday.
