Navy Considers Dress Ruling

WASHINGTON (U.S.)—The Navy is reportedly considering letting its military personnel here wear civilian dress while on duty rather than uniforms—a practice in vogue before World War II. Officials said the proposal will be considered by the Navy Uniform Board at its next meeting. It would apply to sailors at the Pentagon, the Navy Annex and some other assignments in the Washington area.

Textile Mill To Move North

READING, Pa. (U.S.)—A hosiery mill executive says he's found "economic conditions in the North and the South are about equal" and has announced that his firm is moving back to Pennsylvania.

Nicholas Malesky, president of the Bella Co., a hosiery dyeing and finishing firm, said yesterday "the labor situation in the North is more favorable than it has been for many years. More prospective employees are again available."

In bucking a long-time trend in the textile industry, Malesky declared that "the advantages obtained by the move to the South are gradually disappearing." He added that, by moving North, "the company is closer to the markets."

Malesky, of Stowe, Pa., moved his company to Mount Pleasant, Tenn., several years ago from its original site in this area. He will relocate in the former Gold Seal hosiery mills here.

Oregon Voters Poll Reported

SALEM (U.S.)—Oregon, for the 18th straight year, led all states last year in timber production. The state's 1953 timber harvest totaled 8,587,160,000 board feet, which was 1.3 billion feet less than the 1952 production. Douglas County ranked first among the counties with 1,495,316,600 feet, and Lane was next with 1,314,722,000.

Production in other counties included: Coos 677,000,000, Linn 543,000,000, Tillamook 483,899,000, Jackson 456,611,000, Lincoln 434,273,000, Clackamas 389,988,000, Curry 348,428,000, Josephine 245,703,000. In Eastern Oregon Grant County was first with 199,049,000, followed by Klamath with 153,358,000, and Lake with 148,248,000.

Cash Offered For Worthless Bonds

HOUSTON (U.S.)—A Houston brokerage firm is offering \$10 good hard cash for certain examples of the Confederate treasury's handiwork—\$1,000 cotton bonds.

The firm's weekly bulletin made the offer for an unnamed Houston man it said seeks to buy up the \$100,000 Confederate States of America 7 per cent cotton bond issue due in 1883. The bonds were issued for \$1,000 each.

The bulletin said the man "chooses this way to reaffirm his faith in those bygone principles and his conviction that the South today needs sorely to revive and recapture them."
