As these words are written, a most interesting political campaign is nearing its end. It is interesting because, after nearly a decade and a half of war economy, we are readjusting to a peace economy. It isn't easy.

In a war economy, the engine runs at wide-open throttle. It has to run at wide-open throttle, for in wartime we must have production and more production and then STILL MORE PRODUCTION. Modern wars are won or lost on the ability of the combatants to produce. When production is high, we have at least the illusion of great prosperity.

For the moment, the shooting wars are ended. It is an uneasy peace, it is true. But history tells us that a period of uneasy peace usually follows a prolonged period of war. History tells us also that periods of uneasy peace are often followed by periods of solid peace. Maybe it will be that way this time.

We all hope so.
But readjustments from war booms to a normal peacetime economy are never easy. It's hard to forget the booming days when everybody had a job, when overtime was abundant, when prices were high and going steadily higher and wages were high and going steadily higher.
In short —
When we never had it so good.

The Eisenhower administration has had to face this readjustment. In doing so, it has displayed a great deal of courage. In this year of 1954, when the indexes by which we measure what we call prosperity have been steadily declining, there has never been a day when the President and his advisers have not known that by turning on the spigot of inflation they could restore the ILLUSION of prosperity.

They have had the courage to refrain from doing so. I admire them for it — for we can't get back to a normal peacetime economy if we keep turning on the spigot of inflation to BRING BACK THE BOOM.
Since we MUST get back to a normal peacetime economy — I hope the Eisenhower administration is sustained in the balloting next Tuesday and I shall do what I can to bring that about.

All I can do is to vote for candidates who in my opinion will support and sustain the Eisenhower administration. It is really courageous attempt to readjust our economy to a normal peacetime basis. That is all anyone can do.

I shall of course vote to reelect Senator Cordon. He is an able, sincere, hard-working member of the senate. He has represented Oregon well and he has served his country well.
In the second congressional district of Oregon, I shall vote for the reelection of Sam Cohn. He has represented this district ably, and I think he is entitled to another term. I think Eastern Oregon will profit by giving him another term.

On the same principle, and without seeking to discredit his Democratic opponent, I shall vote to reelect Governor Patterson. He has been an able and conscientious governor, and I think the state of Oregon will profit by giving him another term.
In Klamath county, I will cast my vote for Henry Semon, Democrat, and Ed Geary, Republican, for representatives in the legislature. Wyoming Senator Barrett Lauds Cordon's Senate Record In K. Falls Interview

"My purpose in coming to Oregon is to pay my respects to my good friend, Senator Guy Cordon," announced U.S. Senator Frank Barrett Thursday in Klamath Falls. Barrett, from Lusk, Wyoming, served in the House of Representatives, was then elected governor of Wyoming and is now in his second year of a six-year term in the U.S. Senate.

Concerning Senator Cordon, the Wyoming senator said, "I met Guy Cordon more than 12 years ago when he was in Washington representing public lands counties of the Western states. He was very helpful to me on a Jackson Hole legislative matter in which I was involved."
"I formed a very healthy regard for Senator Cordon and I can tell you he is a man with intimate knowledge of all the problems of the public lands states in the West. I was delighted when he was appointed to the Senate."
"I am proud to be associated with a man of the standing of Guy Cordon. I would rate him as one of the top 12 senators from both sides of the aisle. Any one of the 11 western states would be proud and highly honored to have one of their senators chairman of the Interior and Insular Affairs Committee as Senator Cordon is. (I am only a member of the committee and we think that is pretty good.) As if that chairmanship isn't enough, Senator Cordon is chairman of the Interior Committee Appropriations Subcommittee. Representatives of the Bureau of Reclamation have been asked to attend, also, in order that all questions on the proposition can be answered and the various phases of the measure made completely clear in the minds of those eligible to vote.
The operation and maintenance contract covers more than 40,000 acres of land under irrigation in Klamath County extending as far south as the Oregon-California line.

his fellows and perhaps that is true also in his home state."
"If you were to hire somebody to go to Washington to represent you before the executive arm of the government, the President and particularly before Congress, you would select a man who stood pretty well with the party in power. HILLSBORO, Ore. (AP) — The body of William C. Christensen, 61, missing bank president, was found Friday in the Tualatin River south of here.
He had been sought since falling to return home here the night of Oct. 21. The next day his car was found near the river and his hat and coat were at the river's edge. His body was 150 feet downstream and near the opposite side from where he entered the water. That point was established Thursday by bloodhounds handled by Norman Wilson of Los Gatos, Calif. They nosed down to the water's edge where the garments had been found.

Klamath Indian Tribal Council Requests Timber Bids

A stormy session of the Klamath Indian Tribal Council was held Thursday at the Klamath Agency.
Climax of the meeting was a resolution to request that the secretary of Interior be instructed to advertise three timber units for sale and a resolution passed requesting that forest supervisor E. R. Wilcox be ousted from his position and a forester appointed that would cooperate with the executive committee.
Three units of timber known as Puzos No. 28, Puzos No. 29 and Wildhorse No. 24, comprising approximately 7 million board feet of timber and covering approximately 16,000 acres will be offered for competitive bids.
Minimum acceptable bids were reduced after the two Puzos units were advertised last spring with no bids being offered.

President Stumps For Candidates

WITH EISENHOWER (AP) — President Eisenhower, striving to drum up votes for Republicans, told an industrial Detroit audience Friday his administration is solving the unemployment problem without war because "we have a government with a heart."
Police Inspector Arthur J. Heidt estimated crowd of 50,000 persons jammed Cadillac Square in front of the city hall to hear Eisenhower declare:
"I am quite sure we do not want to pay for false prosperity in the blood of our sons on the battlefield."
As he did earlier in Cleveland Friday, the President said prosperity during the Democratic administration was based on war.
He pledged that America will never, during his administration, resort to war to solve unemployment.

WEALTH INDEX

"By every index by which we measure wealth of the nation, this is by far our best year."
"Things are on the upswing."
Eisenhower called for reelection of Sen. Ferguson of Michigan chairman of the Senate Public Policy Committee. Ferguson is being challenged hard by Democrat Patrick V. McNamara.
Addressing a police-estimated crowd of 2,500 persons at Cleveland Hopkins Municipal Airport, the President said prosperity under the Democrats was based on war.
He promised that his administration will do everything possible to find jobs for those out of work, but said the solution under his leadership never will be based on a war economy.

FOUR-STATE TOUR

The President flew to Cleveland from Washington on the first leg of a four-state tour to get out the vote for next Tuesday's election.
He came into Ohio to help GOP Rep. George Bender in his contest for a U.S. Senate seat against the Democratic incumbent, Sen. Thomas A. Burke, who was appointed to succeed the late Sen. Robert A. Taft, a Republican.
In urging all citizens to go to the polls Tuesday, the President sounded the same theme he did in a Washington address Thursday night, when he declared:
"Let's roll up our sleeves, and go harder to work" for election of another Republican-led Congress.
In his Cleveland address, the President said the American people under his administration, have got the kind of government they wanted.
"We were tired of hearing the word Communist," he declared. "And every time it was mentioned, it was called a red herring."
That was an indirect jab at the Truman administration's handling of the subversion problem. Former President Truman, in reply to a newsmen's question, once said that congressional investigations into subversive activities were a red herring designed to divert attention from his legislative program.
