Death Claims Lakeview Man

LAKEVIEW — James E. Bennett, 51, a resident of Lakeview for the past 26 years, died November 22 at his home here.

In 1926 and 1927 Mr. Bennett was manager of the Stone Cash Store

in Klamath Falls; in 1928 he moved to Lakeview as manager of a chain store there. In 1937 in partnership with his brother Del he started the Marketer in Lakeview and also owned the Sportsman's Store. He was a member of the Lake County Fair Board and City Council in 1937 and 1938; the Lakeview BPOE and the Latter Day Saints Church.

Mr. Bennett was born in Poncha, Colorado, the son of Sarah Wardell and Thomas Bennett. He married Maude Hunter in Utah in 1924 who survives. Other survivors are a daughter, Mrs. Beverly Clause, Lakeview; a son, Robert J. Lakeview; two brothers, Del Bennett, Klamath Falls, and Z. W. Bennett, Brookings; two sisters, Mrs. Miles Romney, Eugene and Mrs. Robert Mitchell, Panna, Colorado, and five grandchildren.

Funeral services will be held Friday, November 26, at 3 p.m., at the Elks Building in Lakeview with Don Fossum in charge. Interment in Sunset Park with the Ouseley-Osterman Funeral Home in charge.
