

British Protest Alleged Attack

TAIPEI, Formosa, (AP) — Great Britain today protested to Nationalist China against an alleged attack by two of Chiang Kai-shek's planes on the British freighter Inchewells near the mainland port of Foochow Wednesday.

British Consul Alexander Hermann made a personal call on Gov. C. K. Yen for the purpose. The consul said a written protest will be delivered tomorrow.

The press officer of the Nationalist air force headquarters in Taipei told newsmen he had not heard of the incident.

British reports said the Inchewells (1,800 tons) was attacked while at the Min River bar, west of the Matsau.

British reports said: Four bombs were near misses that caused minor damage. The ship was also machine-gunned.

A Chinese seaman suffered serious stomach injuries, and the second mate was slightly injured.

Ike Plans Trip To Gettysburg

WASHINGTON, (AP) — President Eisenhower leaves today for his Gettysburg farm. He plans to remain there most of next week to study and act on bills passed by Congress.

The White House said yesterday he will return to Washington briefly and then fly on to Denver Aug. 14 or 15 for a vacation "longer than several weeks."

Mrs. Eisenhower plans to accompany the President to the farm today and remain there until Eisenhower returns briefly from Denver to address the American Bar Assn. in Philadelphia Aug. 24. She will join him then for the return to Denver.
