

Managers Squabble At Inking

NEW YORK (UP)—Rocky Marciano and Archie Moore are legally bound today to battle for the heavyweight crown at Yankee Stadium on Sept. 20 but it would take the combined talents of Sherlock Holmes and the Mark Brothers to untangle the maneuvering involved.

The official signing almost hit a snag when Al Weill, Rocky's manager, demanded a \$100,000 forfeit for a return bout. This delayed Monday's proceedings some 2 hours and 35 minutes.

Chronologically it went like this: Weill showed up at the commission offices looking like the proverbial canary-stuffed cat. Quoth the wily Abatino: "This fight isn't signed yet, and wouldn't have been unless our terms were met."

They had been, he smiled. Moore's camp would post the bond with Promoter Jim Norris for a return within 90 days — if Marciano loses.

NEWSPAPER TALK
Charley Johnston, Moore's manager, arrived next, and spluttered that he thought the demand "was all newspaper talk." Now he believes what he reads in the papers.

"We thought it was just talk, although even Moore knew about it," Johnston fumed. "If the Marciano camp isn't worried, as they claim, why are they worrying about the forfeit. It's ridiculous."

Moore, trailing in his wake, fouled up Johnston's lines. "I didn't even know about this \$100,000 business," he said.

Then Julius Helfand, the chairman of the New York Boxing Commission, had his say. "The signing was set for 12:30 p. m., but I was told that Moore had been delayed in transit."

Moore at 12:30 was sitting in the nearby offices of the promoting International Boxing Club. Rocky was in town at noon. The managerial masterminds must have been settling their differences in a sound proof room because mid-town Manhattan seemed quite serene.

Helfand added that he had refused to accept the forfeit memorandum and the return bout clause as part of the contract for the fight. But he did estimate privately that even without commission sanction they apparently would be quite legal.

ROCKY UNCONCERNED
Ordinarily such maneuvering behind closed doors, and such tangled statements, might lead one to suspect of the pending embroglio. But Rocky, the man with the most at stake, appeared quite unconcerned. He was calm and dispassionate despite the heat, the wait and the overplayed reports of his anger at Moore's optimistic precombat claims.

"I was annoyed when Moore was trying to get this fight," he explained. "He seemed to be trying to make people think I was afraid of him. But I'm not angry now. We'll settle this on the night of the 20th."

Moore still was making his claims that he would win in "the greatest fight in 50 years." That, of course, remains in doubt. So does what happened before they signed the contracts Monday.

Federal Game Man Named To Klamath Area

The Klamath Falls office of the United States Fish and Wildlife Service announced this week that the Klamath District has added another game management agent to their staff, bringing the total to three.

Rudy Switzer of Merced, California is the new game agent working out of Klamath Falls. He will be serving with Tom Garrett who has been stationed here for some time.

This is Switzer's first adventure into the federal game service, but his background is filled with game management experience.

Switzer has worked for the California Fish and Game group for seven years and the Arizona state game department for another year. His game enforcement career was split twice because of duty in the services.

The new game agent spent four and one half years in the 41st Infantry Division and the Military Police during the second World War. In the Korean War, Switzer served another two years in the Air Force.

Switzer, 42, is married and has a 9-year-old son. His family is expected to move to Klamath Falls by the middle of September.

The job of Switzer and Garrett is to enforce the federal hunting regulations as well as to help the sportsmen of the area. These agents can be reached at the post office building.

Moore's Oratory Irks Rock

NEW YORK (UP)—If Rocky Marciano belts his sparring partners around with extra vigor in the next few days, they can blame it on Archie Moore.

The heavyweight champion has been doing a slow burn since the 28-year-old Moore, a psychology student, tossed the gauntlet to Rocky at their contract signing ceremony yesterday afternoon.

It happened when the fighters posed for television and newsreel cameramen and were asked to make statements. Commission Chairman Julius Helfand sat between them.

Archie, sporting a mustache and flourishing goatee, was the first to speak. Facing the cameras, he said: "Rocky, I's been a long time and it should be a great fight and make us a lot of money."

Then he turned to face Marciano and added: "Rocky, I do expect to win your title."

Marciano's eyebrows shot up at the unprovoked thrust. After a moment's pause, he turned to Archie and replied: "Archie, you sure have created a lot of interest in this fight. I'll be ready on Sept. 20 for the fight of my life."

The confident light heavyweight king has said before that he expects to beat Rocky but the surprising part was that he said it to his opponent's face. It usually isn't done. As a matter of fact, no one present at the ceremony in Helfand's office could ever recall any fighter ever going beyond the usual "I'll be out to do my best" statement at such an affair.

Archie seldom does anything on the spur of the moment and the chances are that he deliberately planned the remark in his "war of nerves" with the heavyweight ruler.

Seixas Key To US Cup Win

FOREST HILLS, N.Y. (UP)—Vic Seixas, the 32-year-old U.S. champion, today loomed as the key man in the defense of the Davis Cup against Australia starting Friday.

Nearly everyone at the West Side Tennis Club, site of the Challenge Round, has conceded that Seixas will drop his two singles matches and teammate Tony Trabert will win two. The doubles they rate a tossup.

Seixas is one of the few who isn't worrying despite his horrendous record since winning the title here last September. "I'll be ready," he said before stepping on the court for another drill under the eyes of Captain Bill Talbert. "I feel keen again mentally and that's half the battle."

Seixas depends on being "up" rather than blowing his opponent off the courts. His sharpness, quickness of movement and reaction in attacking at the net spell success for him. Without these, he's sunk.

"Everyone knows I'm the worst looking practice player in the game," he said. "That's why I'm not worrying."

Talbert said Seixas had looked vastly improved while practicing at Brookline, Mass., last weekend when the national doubles were rained out.

"Vic is better now than he has been in a long time," commented Talbert while his chief assistant Jack Kramer nodded.

NEW YORK (UP)—As the seething American League race prepares to go into its final month and as the Eastern clubs open their closing foray through the West today, our choice has to be the Chicago White Sox over the Yankees and the Indians, in that order. A flag should wave over Comiskey Park for the first time since 1919.

Marty Marion has done an outstanding job of keeping the Sox "up" to this point, in the face of some hard knocks from the base ball fans, and there is no reason to doubt that he has a team which means to fight it out to the last ditch. Casey Stengel said the other day that he didn't believe this Sox club "is going to fall off the way the others did."

As of today the Sox have battled their two chief rivals to a standstill. They are 9-9 against the Yankees, 8-8 with the Indians. Further, they are in front of the troublesome Boston Red Sox 10-8. That is not the record of an outfit which feels itself inferior and is likely to fold in the showdown certain to come.

Minnie Miason, the club's best hitter, finally has begun to slam them into the corners when it counts. That the Sox managed to remain in contention during the months their leading star was bound in a painful slump is a tribute to their all-around class.

Dick Donovan, out three weeks with an appendectomy, has returned just in time to bolster Marion's already powerful pitching staff for the stretch run. In his first start since his return, Donovan ran his record to 14-4. He.

As for the Indians, one can only believe the recent evidence that their pitching Big Three of Bob Lemon, Early Wynn and Mike Garcia finally is feeling the strain. Up to this point the club's fine relief corps has been able to hold the fort, but it can't last forever in such a tight fit as this one is.

1955 Seasons Set For Dove, Pigeon Shoot

The 1955 season on morning doves opens one half hour before sunrise September 1 and closes at sunset on September 25 according to word received from the local U. S. Fish and Wildlife office.

Federal Game Agent Tom Garrett said in a Tuesday release that the bag and possession limit stands at 10 birds per day.

For those interested in traveling west of the Cascades to hunt band-tail pigeons, the season opens the same as the morning dove hunt but closes at sunset September 30. The daily bag and possession limit for the pigeons is six birds. The season bag limit on band-tails is 24 birds.

No migratory bird stamp is needed to hunt either doves or pigeons. The legal shooting times for doves and pigeons is listed below for the month of September:
