Sale of timber, Klamath Indian Reservation. Sealed bids in duplicate on forms provided, tendered, marked outside "Bids," to the Klamath Indian Agency, Klamath Agency, Oregon, will be received until 2:00 P.M., Pacific Standard Time, November 4, 1955, for the purchase of approximately 80 acres of timber land designated as "Bids." The allotment contains an estimated stand of approximately 100,000 feet B.M. of ponderosa pine, and an undetermined amount of lodgepole pine which will not enter into the determination of value but will be sold separately. The bidder must state the price per thousand feet B.M. of ponderosa pine and \$5.75 per thousand feet B.M. of lodgepole pine. A certified check in the amount of 20 per cent of the total bid price on a solvent bond payable to the Bureau of Indian Affairs must accompany each bid. The deposits will be returned to the successful bidder. The deposit of the successful bidder will be held in lieu of bond pending satisfactory completion of the terms of the contract or retained as liquidated damages in the event the bidder fails to execute the contract within 30 days from acceptance of his bid. The right to waive technical defects and to accept any and all bids is reserved. The contract will specify that all designated timber shall be cut and removed from the tract including slash disposal, will be completed by December 31, 1956. An additional deposit in the amount of 10 per cent of the estimated value at the bid price will be required before cutting begins and in any case not later than thirty days from the date of approval of the contract. The contractor will be required to deck logs in advance of scaling or to conduct logging operations in such a manner that will permit the scaling of timber in as few scaling assignments as possible.
