PITTSBURGH (UPI) — Company and union negotiators renew efforts today to end the week-old strike of CIO Electrical Workers against 30 Westinghouse Electric Corp. plants. Both sides were under an injunction restraining them from violence.

Two telephone bomb threats received by Judge Henry X. O'Brien, who issued the injunction fizzle Monday night.

Judge O'Brien said he received two anonymous telephone calls warning his home would be bombed before midnight Monday as a result of the injunction for, bidding mass picketing at plants in East Pittsburgh and Homewood, Pa. The double-edged ruling also ordered Westinghouse to post a \$10,000 bond to assure it would not provoke "violence or intimidation."

O'Brien dismissed the calls as "the work of a prank or some crackpot," but city detectives and deputy sheriffs maintained a vigil at the jurist's residence throughout the night. The mysterious caller, however, failed to make good on his threat.
