At this point, I'd like to offer a statement that has a somewhat similar application to the needs of hungry people throughout the world.

This slightly cynical statement suggests a highly practical question: How could we get the egg? Well, we might talk somebody into GIVING IT TO US.

Dr. Boerma's pontifical statement to the FAO suggests an equally practical question: Where can the world's potential consumers GET the necessary purchasing power?

But sounds like a nasty crack, but isn't intended as such. What I'm trying to point out is that just GIVING people the things they need seldom produces the prosperity that results in the purchasing power that enables them to acquire the things they want and need.

Far too often, it results in pauperizing people.

Let me cite an example: From the standpoint of soil, Egypt is one of the richest countries in the world. From the earliest beginnings of history, the Nile valley has been looked upon as perhaps the world's most fertile area.

Why is this so? Let's take a look at a situation that is presently threatening to upset the peace of the world: Egypt wants to FIGHT ISRAEL. But it is short on guns.

Let's put it another way: Egypt, with a large area of the world's most fertile soil, is one of the world's most backward agricultural countries.

It is trading its cotton and rice for tractors and multiple-bottom plows and engines and pumps to move water from the Nile into the irrigation ditches of the Nile valley.

Egypt is suffering from lack of the right kind of leadership. People who suffer that lack are almost sure to be hungry.

Lawyers Begin Jury Selection

OAKLAND, Calif. (UP)—A jury of seven men and five women was tentatively seated in the jury box today to hear the kidnapping-murder trial of Burton W. Abbott.

Abbott, 27, is accused of slaying 14-year-old Stephanie Bryan of Berkeley last April. Her body was found near Abbott's Trinity County mountain cabin in July.

Not a word of the jury was to be heard today, but they are expected to begin their selection today at 2 p.m.

Such good progress was made in the choosing of a jury on the opening day of the trial yesterday that District Attorney J. Frank Conroy of Alameda County cautiously guessed a jury may be seated by the end of the week.

Defense attorney Stanley D. Whitney declined to go that far, but he said, "We're going faster than I expected."

Abbott appeared to be at ease. He occasionally took careful notes with a pencil and notebook furnished him by his attorneys.

The only spectators allowed in the courtroom were his red-haired wife, Georgia, his mother, Mrs. Elsie Abbott, and his brother, Mark. They occupied three seats in a rear corner.

Alameda County sheriff's deputies had to restrain a crowd of several hundred persons who tried to crowd into the courtroom. However, no spectators will be allowed during the jury selection period. Court seats were available to the respective jurors.

Fire Destroys Bonanza Home

BONANZA—One of Bonanza's last remaining early day landmarks, the Ada Parsons Sparren home in the center of town was destroyed early this morning by fire.

Planes are believed to have originated in the chimney of the one and one-half story frame home.

Mrs. Cross Carl, a daughter-in-law of the owners, Mr. and Mrs. Norval Carl, who was sleeping upstairs, barely escaped the flames. She was awakened by smoke pouring into her room and rushed to the first floor to awaken Mrs. Norval Carl.

Much of the furniture on the first floor was removed from the burning building but wedding presents of the younger woman, a bride of last spring, were destroyed. The loss was partially covered by insurance.

Mr. and Mrs. Norval Carl, operators of the Oasis Pool Hall, had closed their business, stored part of the equipment in the home and were preparing to move to Washington, Carl is in that state preparing for the move.

The Bonanza Fire Department was called to the fire shortly after it was discovered about 4 a.m. The Klamath County fire equipment was called at 7 a.m. but the fire had progressed too far for the building to be saved.

Civil Service Commissioner Upholds Information Policy

WASHINGTON (AP)—Chairman Philip Young said Tuesday the Civil Service Commission's policy is to give its employees freedom "to discuss public information" and "they are encouraged and expected to do so."

Young was the first of a group of government witnesses to testify before a House Government Operations subcommittee inquiring into federal information policies and complaints of withholding of news by government agencies.

When the subcommittee opened its hearings Monday, James S. Pope, Louisville editor, characterized the commission's information policies as "arrogant."

Pope cited specifically the commission's reply to a questionnaire sent to all agencies by the subcommittee.

In reply, the commission had asserted it has authority to deny access to its records or to refuse information "to enable it to carry out its administrative functions."

Young said the commission seeks to "foster a broader news interest in our activities and objectives" but that its information program is "not a propaganda campaign."

In no event, he said, is information withheld "simply because it may not be favorable to the commission."

Russia Ignores Arms Protest

WASHINGTON (AP)—Russia is reported to have brushed aside a strong protest by Secretary of State Dulles against Communist shipments of big quantities of weapons to Egypt.

Soviet Foreign Minister V. M. Molotov is understood to have made clear that his government will do nothing to stop the flow of Communist tanks, jet fighters and Egyptian. Egypt is paying for them with cotton and rice.

At least half a dozen Communist ships, carrying the first of some 80 million dollars worth of weapons, are reported to have unloaded their cargoes at Egyptian ports, often at night.

As a result, neighboring Israel has also sought new arms supplies, contending, as does Egypt, that they are needed for defense.

Diplomatic officials said Molotov made known his government's refusal to interfere during a far-ranging talk on Middle Eastern problems with Dulles at Geneva.

Details of Dulles' talk with Molotov, his third in six weeks on this problem, have been kept secret. But it was learned that Molotov defended the arms deal, ostensibly concluded between Red Czechoslovakia and Egypt, as a strictly normal commercial transaction to which no one could object.

Plane Crash Kills Children

SEOUL, Korea (UP)—A Mustang fighter plane of the Republic of Korea Air Force plunged into a crowded schoolhouse today, killing 16 children and the pilot.

Twelve other children were injured. The ROK Air Force listed the toll in a revised casualty list issued tonight after announcing eight children dead and no hurt.

The propeller-driven F31 fighter plane, which carried only the pilot, "suddenly plunged into a screw dive," the ROK Air Force announced.

The plane destroyed four classrooms where more than 100 students were attending morning classes. The school was located near the city of Kyongju, an important rail center 110 miles southeast of Seoul.

The dead and injured students were from 10 to 13 years old. The fatally-injured pilot was Cadet Pak Chang So and said he was on a routine training flight.

Ike Prepares Video Talk To Nation

DENVER (AP)—President Eisenhower will address the nation briefly on television and radio when he checks out of Fitzsimons Army Hospital Friday and again when he arrives in Washington that afternoon.

The Denver remarks—the President's first to the country after seven weeks of hospital convalescence—will be at Lowry Air Force Base a moment before he walks up the 17-step ramp to his private plane, Columbine III.

And his equally informal talk in Washington will be at the Military Air Transport Terminal at National Airport when he steps from the plane there.

Veterans Day

Most retail stores will be open on Friday, Veterans Day, it was reported here today.

Many industries will be closed. The major exception will be the lumber mills, which will operate as usual. However, the Oregon State Police reminded all log haulers that no logging trucks will be allowed to operate on the holiday.

A spokesman for the building supply firms and lumber yards announced that these establishments will be closed. However, some major supply houses, including the Lorenz Company, will be open.

Fire Endangers Stars' Homes

VENTURA, Calif. (AP)—A wind-whipped brush fire raged on a 12-mile front Tuesday after burning an estimated 6,000 acres and endangering 300 homes and ranches including those of Hollywood stars Alan Ladd and Eve Arden.

Gusty winds up to 45 m.p.h. blew the out-of-control fire in many directions. It reached the coast through Sycamore Canyon, Headquarters for more than 200 firefighters was set up at Ladd's ranch.

Although flames reached close to dwellings none were burned and no injuries were reported.

The flames were visible more than 20 miles Monday night.

Ladd, his wife, Sue Carol, and their daughter, Alana, 12, prepared to take their horses and personal belongings from their Hidden Valley home when brush and timber burned on their 65-acre ranch. It later appeared out of danger.

When Miss Arden's residence was threatened, she and her husband, actor Brooks West, took many of their possessions to the Ladd residence, which at the time was not in the fire's path.

Ladd joined fire fighters and helped contain the blaze in foothills behind Hidden Valley. Actor George Brent's ranch also was momentarily threatened.

SF Residents Tramp To Polls

By UNITED PRESS Voters went to the polls in San Francisco and several other California cities today to vote on local issues.

San Francisco voters were to choose a new mayor to succeed Elmer E. Robinson. Seven candidates were in the running, but the top contenders were Supervisor George Christopher and George R. Reilly, member of the state Board of Equalization.

Also on the ballot were 14 propositions, four of them for bond issues totaling \$5 million dollars. One was a \$4 million dollar proposal for building power dams on the Tuolumne River as part of the Hetch Hetchy system.

The voters also chose six supervisors from among 21 candidates, and cast complimentary votes, if they wanted, for the unopposed candidates seeking the offices of district attorney, sheriff and four municipal judgeships.

C. A. Reed Killed In Air Accident

Collins A. Reed, 41-year-old lumber buyer, was killed shortly before noon Monday when the four-place Navion airplane he was piloting struck a radio tower at the Lovensess Lumber Company plant in Canby, California. Mr. Reed was alone in the aircraft.

According to announcer Ted Payne of radio station KONO, Alturas, who reached the scene a short time after the accident, one wing of the plane was sheared off and the aircraft crashed on the right-of-way of the Southern Pacific railroad.

Two lumber loaders, Bill McKuen and Ivan Grove, who were working in a boxcar nearby, pulled Mr. Reed from the wreckage. He died a few minutes later.

The plane was owned by the Adams Lumber Company, of Lakeview. Mr. Reed had just taken off from a small field near Canby a few minutes before the crash.

Witnesses said he was circling over the lumber plant when the aircraft hit the private radio tower. The Civil Aeronautics Administration is investigating the accident.

Mr. Reed was an experienced pilot and had flown for many years. He served with 20th Ferry Command of the U.S. Air Force Air Transport Command during World War II serving for sometime in India and Burma. He ended the war with a distinguished record.

Mr. Reed, who resided at 821 Washington Street, Klamath Falls, is survived by his widow, Louise E. Reed; a son Bradford Reed, Menlo Park, California; stepdaughter Carolyn Reed, Klamath Falls; son, Robert E. Fulton; his father Fred Reed; and stepmother Caroline E. Reed, Kelson, and a half-brother Robert Reed, also Kelson.

His grandmother, Mrs. Anna Jones and aunt Mrs. Rachel Kaler resided in Klamath Falls.

He was a member of the Masonic Order, Mt. Taber Lodge, AF&AM, Portland, as a 32nd Degree Mason; Scottish Rite, Eugene; The Quiet Birdmen and the Baptist Church.

The funeral is planned for 2 p.m. Thursday with the Klamath Masonic Lodge conducting the services and O'Hair's Memorial Chapel in charge of arrangements. Place of interment to be announced.

Turncoats File For Freedom

SAN FRANCISCO (UP)—Federal Judge Louis E. Goodman scheduled a hearing late today to consider a plea for freedom filed by attorneys for three ex-GI turncoats.

The attorneys had sought writs of habeas corpus two months ago, but Judge Goodman deferred acting on them until the U.S. Supreme Court ruled yesterday that the Army may not try discharged servicemen for offenses committed while in the service.

The turncoats are William Cowart, 22, Dalton, Ga.; Lewis Griggs, Jacksonville, Tex.; and Otto Bell, 24, Hillsboro, Miss. They were charged with collaborating with the Communists while prisoners of the Reds in North Korea.

Communist Raps Eden's Union Plan

GENEVA (AP)—Soviet Foreign Minister Molotov Tuesday flatly and completely rejected Western proposals for the unification of East and West Germany through free elections.

In a lengthy statement at the Big Four foreign ministers' conference after weekend consultations in Moscow, Molotov showed not the slightest evidence of a softening Soviet policy on Germany in any respect.

His stand was obviously a sharp disappointment to the three Western foreign ministers who have spent many days in argument with him here.

He declared the Eden plan for merging of the two Germanys by steps beginning with free elections would "provoke general dislocation in Germany." He dismissed last Friday's Western proposal as simply a subordinate proposition under the Eden plan.

In that proposal the West had called for elections in Germany next September.

The main point of the Western proposal is "not the reunification of Germany or free elections," Molotov told the West in summing up his position.

The main purpose, he asserted, "is to get a united Germany to join NATO and the Western European Union and to bring about the militarization of all Germany."

The Western proposals, he declared, have "no relationship" to European security.

In connection with Russia's own approach to the problem, Molotov called again for creation of an "all-German council," composed of representatives of the East and West German regimes. He declared that means for reunifying Germany should be found, but he said the pace is not simple and "time and patience" are required.

Before Molotov spoke, the Western foreign ministers ruled out any solution to the German problem requiring a reunited Germany to choose neutrality.

French Foreign Minister Pinay, leading off for the West in the resumed parley, declared that France, Britain and the U.S. never will accept the idea of a united Germany unless it is neutral.

Pinay told Molotov that Germany should be free to decide after she reunites whether to join the North Atlantic Alliance or, for that matter, the Warsaw Eastern European bloc. He contended there are safeguards in NATO against unbridled German rearmament and he suggested that similar safeguards should be contained in the Warsaw pact. British Foreign Secretary Aneurin Bevan, who followed Pinay, supported him.

Molotov, who went to Moscow last weekend and participated in the celebration of the Bolshevik revolution anniversary, indicated there last night he might be bringing new proposals to Geneva.

Answering a question at a Kremlin reception, he said: "I arrived in Moscow with good baggage and I am leaving with even better baggage" because "I told of Molotov's remark Soviet Premier Bulganin commented with a smile, "that is exactly right."

Molotov added he thought it possible for the Geneva meeting of foreign ministers to produce an East-West agreement, a saying, "why should we have gone to Geneva if we did not think we could reach agreement."

"Of course," he continued, "there will be certain difficulties on some questions. But you know the Russian proverb, 'Moscow was not built in one day.'"

Whatever the Russian's next move may be, it seemed clear the conference was going into a critical phase and that Germany was the heart of it.

Knowland Hits Labor Leaders

MIAMI, Fla. (AP)—Sen. Knowland (R-Calif.) said Tuesday some labor leaders hope to capture the Democratic Party and gain control of the government by 1960, if not in 1956.

Knowland, the Senate Republican leader, said in a speech prepared for the U.S. Savings and Loan League that the people and Congress are going to watch how the leaders of the combined AFL and CIO attempt to wield political power.

"There are some in the ranks of the new labor combine who visualize taking control of the Democratic Party as they have in Michigan and making it into the American equivalent of the British Labor Party," he declared.

"They hope by capturing a great existing party to retain the name, the tradition and the ties and loyalties of generations. By 1960 if not in 1956, they plan thereby to gain control over the governmental structure of this country. This is not in the best interests of labor or the nation as a whole."
