### West Big Three Ministers Confer On Suez Problem

UNITED NATIONS, N.Y. —  
The foreign ministers of the West-  
ern Big Three conferred on the  
Suez problem Wednesday amid  
widespread reports Britain was  
preparing to soften her position  
on management of the vital wa-  
terway.

A British spokesman insisted  
there had been no retreat from the  
original demands for interna-  
tional control of the canal. He  
indicated, however, that the Brit-  
ish were flexible on the question  
of actual operation so long as  
there was an international group  
to see that all countries had free  
access.

These developments came as  
British Foreign Secretary Selwyn  
Lloyd, French Foreign Minister  
Christian Pineau, and Egyptian  
Foreign Minister Mahmoud Fawzi  
prepared for their second  
private session with U.N. Secre-

### McKay Here For Final Vote Drive

Former Interior Secretary  
Douglas McKay, Republican candi-  
date for United States senator,  
landed at Klamath Falls Municipal  
Airport at 12:45 p.m. Wednes-  
day to make a final drive for  
votes.

His chartered twin-engine Aero  
Commander plane was two hours  
late on its trip from Portland.  
Mrs. McKay was with the former  
Oregon governor.

McKay said President Eisen-  
hower's fighting speech from  
Pittsburgh Tuesday night had

pumped new enthusiasm into the  
Republicans of Oregon.

"I have covered the state thor-  
oughly," he added, "and I find  
an upsurge of support for Presi-  
dent Eisenhower."

Asked about his own campaign  
McKay declared, "It's going  
fine." When questioned about his  
opponent, Democratic Senator  
Wayne L. Morse, McKay said:  
"I don't know anything about  
him. Who is he?"

McKay was met at the airport  
by a delegation of Republican  
leaders, including Bob Mest and  
Ellen Clark, co-chairmen of his  
Klamath Basin Campaign Com-  
mittee. He immediately started on  
a round of conferences and meet-  
ings.

McKay will be guest of honor  
tonight at a no-host cocktail party  
and dinner in the Pelican Cafe to  
which the public is invited.

### Indian Tax Ruling Given

In a ruling handed down from  
the Oregon State Attorney Gen-  
eral's office by William Dought-  
erty, special assistant to the at-  
torney general in charge of tax  
matters, it was announced that  
members of the Klamath Indian  
Tribe will not have to pay inheri-  
tance taxes on lands they receive  
as a result of the termination of  
their reservation.

J. C. O'Neill, attorney for the  
Klamath Indians in Klamath Falls  
stated that tribal members will  
not have to pay tax on lands in-  
herited through death.

The ruling was based on a  
similar case handled by the United  
States Supreme Court entitled  
West vs. the Oklahoma Tax Com-  
mission.

### Wheat Crop Estimate Given

WASHINGTON — The Agri-  
culture Department Wednesday  
estimated this year's wheat crop  
at 975,517,000 bushels, and the  
corn crop at 3,369,102,000 bushels.  
The wheat estimate is 8,943,000  
bushels more than last month's  
forecast of 966,574,000 bushels. It  
compared with 936,761,000 last  
year and 1,143,289,000 for the 10-  
year average. This crop was  
grown under marketing quotas de-  
signed to prevent surplus produc-  
tion.

The corn figure is 33,372,000  
bushels more than last month's  
department forecast of 3,335,730,  
000 bushels. It compares with last  
year's crop of 3,241,536,000 and  
with the ten-year (1945-54) aver-  
age of 3,064,389,000.

## High Court Orders New Trial For Reds

WASHINGTON — The Su-  
preme Court Wednesday ordered  
a new trial for Steve Nelson and  
four other Communist Party lead-  
ers convicted under the Smith  
Act. The government had suggest-  
ed a hearing on the truthfulness  
of one of its witnesses but had  
opposed a new trial.

The high court ruling was an-  
nounced by Chief Justice Warren  
after the court had heard argu-  
ments on the government motion.  
Warren said the government

motion was denied and the case  
was remanded to the District  
Court at Pittsburgh with direc-  
tions to grant a new trial.

He further said that Justices  
Frankfurter, Harlan and Burton  
thought the government motion  
should be granted and reserved  
the right to file written opinions.

In an unusual motion, the gov-  
ernment had asked the court to  
order a hearing by the District  
Court on the veracity of Joseph  
D. Mazzei who testified at the  
1953 trial of the defendants.

The Justice Department said it  
believes Mazzei's Pittsburgh testi-  
mony was truthful but that in  
other proceedings Mazzei gave  
testimony which the government  
"now has serious reason to  
doubt."

Nelson, Communist leader in  
western Pennsylvania, and his co-  
defendants were convicted of con-  
spiracy to advocate the over-  
throw of the government by force  
and violence.

Each was sentenced to five  
years in prison. They appealed to  
the Supreme Court.

The Democrats surged ahead  
overnight after the Republicans  
had held a favorable position in  
the first scanty returns from the  
usually conservative Southeastern  
Alaska Division (district) in the  
early tally before the polls closed  
in heavily Democratic western  
Alaska.

By way of comparison of re-  
sults which are watched nation-  
ally for possible political trend sig-  
nificance, the Republicans won 21  
out of 24 House seats in the 1952  
presidential year election and six  
out of nine seats at stake in the  
Senate.

In 1954, the tide swung back to  
the election of 21 Democrats and  
3 Republicans to the House and  
the Democrats swept all 9 seats  
at stake in the Senate.

The swing in favor of the Demo-  
crats came largely on big blocks  
of votes from the populous Anch-  
orage and Fairbanks districts, al-  
though it was at Fairbanks that  
three of the five Republicans were  
leading for the Alaska Senate.

The Alaska election was  
watched closely nationally be-  
cause in recent years the swing  
of congressional elections has fol-  
lowed the Alaska weathervane.

At a special meeting of the  
Klamath Indian Tribal Executive  
Committee, Delford Lang, com-  
mittee chairman, appointed three  
members of the committee to re-  
present the tribe at the coming  
congressional hearing of the Sen-  
ate Interior and Insular Affairs  
sub-committee slated for October  
18 in Klamath Falls.

The three men named were  
Boyd Jackson, Jessie L. Kirk and  
Elmathan Davis. They will go be-  
fore the group which will be pre-  
sided over by Senator James E.  
Murray of Montana and air their  
views on the progress and possible  
changes of the termination pro-  
gram as provided for by Public  
Law 567.

Senator Gore is coming here  
primarily to plug for the reelec-  
tion of Senator Wayne L. Morse.  
Gore is a member of the Senate  
Public Works Committee and the  
Joint Committee on Atomic En-  
ergy.

### Court Denies Patterson Admission To State Bar

SALEM — Frank Victor Pat-  
terson, Portland, was denied ad-  
mission to the bar Wednesday be-  
cause of his affiliation with the  
Communist Party.

The Oregon Supreme Court unan-  
imously ruled that Patterson,  
who passed the state bar exami-  
nation three years ago, could not  
be admitted to law practice be-  
cause it would be contrary to the  
public interest.

The high court decision, by Jus-  
tice Hall S. Lusk, found that Pat-  
terson was an active leader in the  
Communist Party for four years,  
although he claimed to have been  
expelled in 1949.

Patterson claimed that the party  
did not teach overthrow of the  
government, and that he did not  
believe that doctrine.

The decision said:  
"The Communist Party during  
the years 1946-49 was not, as it is

not today, just another political  
party" and we cannot accept peti-  
tioner's (Patterson's) protesta-  
tions that all it sought was the  
establishment of a system of so-  
cialism within the framework of  
our constitutional form of govern-  
ment, and that it was dedicated  
only to the preservation of demo-  
cratic principles of government  
and democratic laws and legisla-  
tion and the election of public of-  
ficials dedicated to the preserva-  
tion of the constitution.

"Nor are we persuaded that the  
petitioner did not understand or  
believe in the gospel which, as an  
active member and high officer  
of the party in Oregon, he helped  
to disseminate."

After noting that Patterson has  
not expressed any regret at hav-  
ing belonged to the party and that  
he found little fault with it, the  
court continued:

"He did not in our opinion tell  
the truth either to the board of  
bar examiners or in his testimony  
before the panel of judges about  
the real character and aims of  
the Communist Party and his be-  
lief in them. That alone is suffi-  
cient to support the finding that  
he is not within the meaning of  
our statute a person of good moral  
character and as such entitled  
to admission as an attorney."

The board of bar examiners held  
a hearing, after which it ruled  
against Patterson.

He then appealed to the Su-  
preme Court, which referred the  
case to Circuit Judges Arlie G.  
Walker, McMinnville; William G.  
East, Eugene; and the late Rex  
Kimmel, Salem.

## Homers Pave Way For New Yorkers

BROOKLYN — The New York Yankees overwhelmed the Brooklyn Dodgers and Don Newcombe with a record-breaking home run assault Wednesday and won the World Series, 4 games to 3, with a 9-0 victory.

Yogi Berra hit two homers and Bill Skowron smashed a grand slam homer to back up superb 3-hit pitching by 23-year-old Johnny Kucks.

The Yankees thus duplicated Brooklyn's 1955 feat of winning a seven-game series after losing the first two games. It was the Yanks' 17th World Series victory in 22 attempts since 1921 and their sixth in seven series against Brooklyn.

The Dodgers took the first two games in Ebbets Field. The Yanks won the next three in their stadium and then Brooklyn squared the series Tuesday in their home park. Wednesday's game was the first break-through by the visiting team.

Berra, who clubbed a bases-loaded homer off Newcombe in the second game, hit over the right field wall the first two times he came to bat against Newk Wednesday, each time with a man on base. After that he was intentionally passed and one of those walks set up Skowron's bases-full blow off Roger Craig, the third Dodger pitcher. Elton Howard belted the other Yankee homer, with Newcombe as the victim.

**PAID ATTENDANCE**  
The seven-game series drew a paid attendance of 345,903 with 33,782 fans watching the final game. The net receipts were \$2,163,353.89.

The four Yankee homers set a series record of 12 by one club in a series, breaking the mark of ten set by the 1952 Yanks, and Berra, with ten runs batted in during the series, smashed an other record.

The Yankees, who hadn't won a series game in Ebbets Field since Oct. 4, 1953, presented a changed lineup for the final game, benching veteran Enos Slaughter and Joe Collins in favor of Howard and Skowron. Then Manager Casey Stengel called on young Kucks, who had seen action only in relief roles in the series, as his starting pitcher.

These moves paid off with an

unbeatable combination of pitching and power. Kucks gave up a hit to Duke Snider in the first, but didn't allow another until Carl Furillo singled in the eighth. Snider made the third hit with two out in the ninth.

**FIVE PITCHERS**  
Meanwhile the Dodgers used five pitchers. Newcombe, who never has won a World Series game, started but was fourth after Howard's homer in the fifth but hit behind 5-0. Don Bessent stopped the Yanks until he was removed for a pinch hitter in the sixth. Craig, who followed him, didn't get a man out. A single by Martin and walks to Mickey Mantle and Berra loaded the bases. Then Skowron slammed his homer into the lower left field stands to complete the rout. Ed Roebuck and Carl Erskine were the other Dodger pitchers, who gave up a total of ten hits.
