Search Finds Stockholders Sought By Chicago Firm

Money that is lying in wait in Chicago for some stockholders in that city, touched off a manhunt here that led news snoopers to points in California in search of two lucky men, former residents of Klamath Falls.

The search was sparked by a communication from William F. Hunter, public relations director of Byllesby & Company which stated that "sizable" dividends on their Byllesby stock had accrued to their credit and was "burning a hole" in the company exchequer.

Sought were Jack Lewis Long, once of 615 North Eighth Street, and Robert H. Tibbals, a former employee of the California Oregon Power Company.

The trail led to power company records, the usual leads of "may-be he knows," to cooperative telephone operators—who can usually nose out an individual if they have only a name; hospital officials, the county court and vehicle records.

The search paid off. Long, a recent bridegroom and a former Herald and News paper delivery boy, had been mentioned in a recent society item. A brother, Dr. George Long of Tigard, Oregon, gave family background "just in case" the trail turned cold and his brother could not be reached by telephone. He too had dividend money coming.

Jack Long, a maintenance mechanic for the Fly Tiger Air Line in Burbank, California, graduate of Klamath Union High School, now nearing his 34th birthday, had spent seven years in Alaska operating his own flying service after serving in the U.S. Air Force during World War II. He had "bought a little stock in

Byllesby & Company," he said and has been getting a 63 cent dividend check every three months for some time, but had paid no attention to a considerable block of stock purchased for him and his brother by their father, the late John M. Long, back about 1934. His father had been employed by the California Oregon Power Company while living here.

It was in 1941 that Jack Long carried the Herald and News to readers in the Hillside-Esplanade district. Long's mother, the late Elizabeth Long, a graduate nurse, was a nurse at Klamath Valley Hospital.

A friend of the Long family, William Applegate of Klamath Falls, has also notified Long of the money waiting for him.

Robert H. Tibbals lived in this city for several years, leaving about 20 years ago to locate at 675 E. San Ysidro Boulevard, San Ysidro, California. He is an uncle of Jack Propst, 4539 Clinton Avenue, now believed to be employed in civil service in the California town.

The clipping published recently in the Herald and News was airmailed to him by his relatives here.

Hunter, the public relations man, has been notified of the whereabouts of his two clients.

Army Issues Diet Order

WASHINGTON—The Army, already pressed to cut the fat from its spending program, is also attacking fat on another front—that of its personnel.

A recent order, sent out in the form of a 42-page supply bulletin, recommends a 15-day low calorie diet. It's up to local commanders whether—and on whom—to put it into effect.

The bulletin suggests the diet "is applicable for use for personnel who have consistently put on weight due to the consumption of a ration of higher caloric value than required by their physical activity." Or in other words, those who get fat because they eat too much.

Then, in a tactical vein, it adds:

"The success of using this menu will depend on such factors as—the designation of a separate mess where it will be served, proper indoctrination and instruction on good eating habits, and motivating the individual by convincing him that he will both feel and look better if he eats a diet more in keeping with his energy requirements."

The order says "no personnel will be required to subsist on this menu without the prior approval of the local surgeon."

Atom Spies Facing Quiz

WASHINGTON—Two convicted atom spies—David Greenglass and Harry Gold—may be questioned next week about information that the Rosenberg spy ring gave U.S. space secrets to Russia in 1947 or 1948.

Robert Morris, counsel for the Senate Internal Security subcommittee said today the two may appear at subcommittee hearings next week in Memphis.

Julius and Ethel Rosenberg were executed as atomic spies in 1953. The testimony of Greenglass and Gold helped convict the pair. Mrs. Rosenberg was Greenglass' sister.

Morris said in a telephone interview from Point Pleasant, N.J., that the Justice Department indicated it would try to have both Greenglass and Gold on hand when the Memphis hearings open next Tuesday.

The committee lawyer added that both spies, who are now imprisoned, will be questioned about Greenglass' testimony at the Rosenberg trial that Rosenberg stole secrets about space satellites and atom-powered planes for the Russians.

Labor Party Scores Win
IPSWICH, England—The steady decline of voter support for Britain's governing Conservative party continued yesterday in another election for a parliamentary vacancy.

Laborite Dingle Foot defeated his Conservative opponent John Cobbold, with more than twice as many votes to spare than the Labor candidate in Ipswich had in the 1955 general election.

Both parties polled fewer votes than in 1955, however, as a Liberal candidate made a surprisingly strong showing. The small Liberal party has been picking up by-election support lately from voters dissatisfied with both parties.

The Conservative party still retains its majority of about 60 seats in the House of Commons.

The Tory government does not have to call a general election until 1960 unless defeated on a major issue.
